ORDER:

The Examiner of Local Fund Accounts in his letter read above has stated that the Municipal Employees who retired prior to 14.1.70 were granted Adhoc Pension from the Funds of the respective Municipal Councils and Township Committees, that the Municipal employees who retired between 14.1.70 and 2.10.70 and whose minimum of the time scale of pay was less than Rs.90/- were given adhoc pension from State Funds, and that consequent to the issue of orders in G.O.Ms.No.512, Municipal Administration and Water Supply, dated 23.4.86 both the categories of adhoc pensioners have to be treated as regular pensioners with all benefits such as Pension and Death-cum-Retirement Gratuity including Family Pension as in the case of regular Municipal Pensioners with retrospetive effect from 14.1.70 and 2.10.70 respectively. As such, he has reported that the eligible legal heirs of the deceased adhoc pensioners who retired prior to 14.1.70 and* those who and 2.10.70 would now become entitled to Family Pension from the day following the date of death of Adhoc Pensioners.
