ORDER:

The Ministry of Housing and Urban Affairs, Government of India has launched Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0) on 01.10.2021. The key components of the Mission are (a) Universal coverage of water supply; (b) Sewerage, Septage management and recycle / reuse of treated used water; (c) Rejuvenation of water bodies (including urban wet lands); and (d) Creation of green spaces.

2. Administrative sanction for implementation of Atal Mission for Rejuvenation and Urban Transformation 2.0 in the State has been accorded and the State High Powered Steering Committee (SHPSC) headed by the Chief Secretary to Government has been constituted for the approval of the Projects under the Mission, vide the Government Order first read above.

3. In the letter third read above, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure

Development Corporation Limited has stated that, the State High Powered Steering Committee (SHPS) of Atal Mission for Rejuvenation and Urban Transformation 2.0 during its 5th meeting held on 28.11.2022 considered the proposal of the Chennai Metropolitan Water Supply and Sewerage Board for setting up of dedicated GIS control room at its Head office at Chintadripet at a total cost of Rs.17.80 crore under the Administrative and Office Expenses Fund of the Atal Mission for Rejuvenation and Urban Transformation. The project proposal includes hosting server in Tamil Nadu State Data Centre (TNSDC) as well as data recovery, procurement of workstations and survey instruments, etc., as detailed below:

The work of "Preparation of Assets and Utility Maps using Geo-spatial techniques" has been taken up by the Chennai Metropolitan Water Supply and Sewerage Board under the Asian Development Bank assisted Tamil Nadu Urban Flagship Investment Program (TNUFIP).

One of the assignments is to prepare a system study report, which covers the preparation of Detailed Project Report for setting up a GIS control room and procurement of the GIS application software required for managing the assets in e-platform and the required hardware for hosting the software.

4. The State High Powered Steering Committee (SHPS) of Atal Mission for Rejuvenation and Urban Transformation 2.0, vide the minutes of its 5th meeting held on 28.11.2022 second read above, has approved-among others - the project of setting up of dedicated GIS control room at the Head office of Chennai Metropolitan Water Supply and Sewerage Board at a total cost of Rs.17.80 crore under Administrative and Office Expenses (A&OE) Fund of Atal Mission for Rejuvenation and Urban Transformation.

5. Accordingly, the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to issue necessary administrative orders for the above project.

6. The Government after careful examination of the proposal of the Mission Director, Atal Mission for Rejuvenation and Urban Transformation and the Additional Chief Secretary / Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited, have decided to accept the same and accordingly issue administrative sanction for the project of setting up of dedicated GIS control room at the Head office of Chennai Metropolitan Water Supply and Sewerage Board at a total project cost of Rs.17.80 crore (Rupees seventeen crore and eighty lakh only) under the Administrative and Office Expenses (A&OE) Fund of Atal Mission for Rejuvenation and Urban Transformation as approved by the State High Powered Steering Committee at its 5th meeting of Atal Mission for Rejuvenation and Urban Transformation 2.0 held on 28.11.2022, as detailed at para 3 above.

7. This order issues with the concurrence of the Finance Department vide its U.O. No.64/DS(LBT)/2023, Dated 20.01.2023.
