## **ORDER:**

The Government, to meet the aspirational needs of the people in urban areas while bridging the resources gap, has announced the new flagship program, viz Kalaignar Nagarpura Mempattu Thittam (KNMT).

2. Accordingly, in the Government Order first read above, Guidelines have been issued for the implementation of Kalaignar Nagarpura Membattu

Thittam with an allocation of Rs.1000 Crore in the budget for the year 2021-22 and in the Government Order second read above, orders have been issued for the release of the said allocation of Rs.1000 Crore.

- 3. Based on the approval of the Project Sanctioning and Monitoring Committee (PSMC) under Kalaignar Nagarpura Mempattu Thittam at its first meeting held on 11.10.2021, in the Government Order third read above, Administrative Sanction has been accorded for the implementation of 36 Park Projects in 35 Municipalities at a cost of Rs.1,965.53 lakh and 7 Numbers of Crematorium projects to be implemented in 7 Municipalities at a cost of Rs.1,045 lakh under KNMT 2021-22, subject to the conditions specified in the appraisal reports of respective projects.
- 4. Further, based on the approval of the Project Sanctioning and Monitoring Committee (PSMC) of Kalaignar Nagarpura Mempattu Thittam in its Circular Resolution No. 1/2021 dated 28.10.2021, vide the Government Order fourth read above, Administrative Sanction has been accorded for the following projects, subject to the conditions specified in the appraisal reports of respective projects.
