ORDER:

In the Government order first read above, orders have been issued to implement the scheme viz., Innovation Voucher Programme (IVP) to promote research and innovation among Micro, Small and Medium Enterprises and Startups. Further, certain amendments have also been issued in the Government Order second read above.

- 2. The selection process of the Innovation Voucher Programme (IVP) award involves two rounds of Screening by the following committees:-
 - 1. Innovation Voucher Programme (IVP) Technical Committee.
 - 2. Innovation Voucher Programme (IVP) Steering Committee.

While Technical Committee screening primarily access the innovation quotient and technical merit of the proposal, Steering Committee largely focus screening on commercial viability of the proposed product.

- 3. In this regard, the Director (FAC), Entrepreneurship Development and Innovation Institute Tamil Nadu has requested the Government to reconstitute the Technical and Steering Committees as a Single Screening Committee so as to evaluate the applications under the Chairmanship of Additional Director, Entrepreneurship Development and Innovation Institute-Tamil Nadu as most of the members of the Technical Committee are present in the Steering Committee and members of the Committee gained sufficient experience in evaluating the application.
- 4. The Government after careful examination of the proposal of the Director (FAC), Entrepreneurship Development and Innovation Institute Tamil Nadu have decided to accept it and amend the guidelines issued in the Government Orders first and second read above by reconstituting the Technical Committee and Steering Committees as a Single Innovation Voucher Programme (IVP) Screening Committee with the following members to evaluate Innovation Voucher Programme (IVP) applications:-
