### **ORDER :**

In the G.O.Ms.No.44, Micro, Small and Medium Enterprises (C) Department, dated 4.9.2013, para 7(2), there was a condition specifying that the Special Purpose Vehicle requesting assistance under the new scheme for the formation of New Industrial Estates to relocate the industries in congested area, must be registered as a non-profit company under Section 25 of the Companies Act. Government has decided to amend this provision and exempt the requirement of Special Purpose Vehicle as a Section 25 Company for the formation of New Industrial Estate to relocate the industries in congested area.

2. Therefore, the following amendment is issued to the G.O.Ms.No.44, Micro, Small and Medium Enterprises (C) Department, dated 4.9.2013:-
