ORDER:

In Government Order first read above, an Expert Committee has been constituted by the State Government to formulate schemes for revival of MSMEs in Tamil Nadu and the Committee is requested to submit its report within three months.

2. In the reference second read above, the Industries Commissioner and Director of Industries and Commerce has stated that:-

The Committee is on the job of consulting with various industrial associations, clusters, and the Government Departments and conducted more than 60 meetings virtually to analyze the problems and existing ecosystem of MSMEs in Tamil Nadu and the Committee had exhaustive meetings on the factors / institutions governing the MSMEs sustainability.

The working group of the Expert Committee has contacted various Statutory Government Departments physically and in the process of finding out the bottlenecks in the Ease of Doing Business (e.g.) Chennai Metropolitan

Development Authority, Directorate of Town and Country Planning offices wherein critical processing of MSMEs application are done. The Expert Committee is in the final stage of preparing the detailed Report. A special meeting was held on 13.12.2021 with Hon'ble Chief Minister's Financial Advisory Committee, Chaired by Dr. Raghuram Rajan. Based on the discussions, the Expert Committee would like to incorporate few inputs in the report to be submitted. The committee has completed the draft report which is under circulation now, among the members.

The final concluding meeting of the committee members will be arranged physically to finalize the report early. In the above regard, the Expert Committee requires extension of time for the completion and submission of report.

- 3. In the above juncture, being the Member Convener of Expert Committee for Revival of MSMEs in Tamil Nadu, the Industries Commissioner and Director of Industries and Commerce has requested the Government to grant further extension of time till the end of February, 2022 for the completion and submission of the Committee Report.
- 4. The Government accept the above proposal of the Industries Commissioner and Director of Industries and Commerce and grant extension of time for the Expert Committee till 28.02.2022 for the completion and submission of its Report.
- 5. This order issues with the concurrence of Additional Chief Secretary, Finance vide its U.O. No.462/FS/P/2022, dated 04.02.2022.
