The Hon'ble Chief Minister has Announcement under Rule 110 in the Tamil Nadu Legislative Assembly on 24.07.2014 that, a new Additional Building with an area of 30000 sft, at a cost of Rs.9.00 crore, will be constructed at Government Technical Training Centre, Guindy to fulfill the norms of All India Council for Technical Education (AICTE), New Delhi.

- 2. Based on the announcement the Principal Secretary / Industries Commissioner and Director of Industries and Commerce, has stated that the Government Technical Training Centre, Guindy was established in the year 1962 and offering 3 years Diploma Courses in Mechanical Engineering for more than 50 years, in the following branches.
 - Diploma in Mechanical Engineering (Tool & Die)
 - Diploma in Mechanical Engineering (refrigeration and Air Conditioning)

The above Courses are approved by All India Council for Technical Education (AICTE). The sanctioned strength for the above courses along with later with lateral entry admission is 144 candidates. All India Council for Technical Techni Technical Education (AICTE) approval is mandatory for running these Courses. Adding regular and lateral admission commenced from the year 2014-15 2014-15 the total strength of the students for all the three years well be increased for increased from 210 to 408 students from the coming years.
