### **ORDER:**

The Hon'ble Chief Minister has made the following announcement on 14.1.2016:

வேலையற்ற பட்டதாரிகளின் வேலை உறுதித் திட்டத்தின் கீழ் சிறு தொழில்களுக்கு 25 சதவீத மூலதன மானியத்துடன் ஐந்து லட்சம் ரூபாய் வரை கடன் வழங்கும் திட்டம் தமிழக அரசால் செயல்படுத்தப்பட்டு வருகிறது. இத்திட்டத்தின்படி ஆண்டுக்கு 5,000 இளைஞர்களுக்கு கடன் வழங்கப்பட்டு வருகிறது. வெள்ளம் பாதித்த மாவட்டங்களில் உள்ள தகுதியான இளைஞர்கள் அனைவருக்கும் இத்திட்டத்தின்படி 25 சதவீத மூலதன மானியத்துடன் ஐந்து லட்சம் ரூபாய் வரையிலான கடன் வழங்கிட நான் உத்தரவிட்டுள்ளேன். இத்திட்டத்தில் நிர்ணயிக்கப்பட்ட பயிற்சி பெறப்பட வேண்டும் என்ற நிபந்தனையிலிருந்தும் விலக்கு அளித்து உடனடியாக கடன் வழங்கவும் நான் உத்தரவிட்டுள்ளேன்.

2. In the Government Order first read above, the Government have approved the Unemployed Youth Employment Generation Programme and issued order to implement the scheme from the year 2010-11 onwards.

3. In the Government Order second read above, the present rate of subsidy has been enhanced from 15% to 25% of the project cost. Similarly, the maximum subsidy amount has been enhanced from Rs.75,000/- to Rs.1,25,000/- per beneficiary under Unemployed Youth Employment Generation Programme (UYEGP).

4. Based on the announcement, the Principal Secretary / Industries Commissioner and Director of Industries and Commerce has requested the Government to issue the following orders.

- a) To exempt all the eligible beneficiaries from flood affected Districts/ Areas from undergoing Entrepreneurship Development Programme training under Unemployed Youth Employment Generation Programme,
- b) To assist the eligible existing Micro Enterprises affected by the flood under this package.
- c) To allocate an amount of Rs.2515.00 lakh towards individual based subsidy and Contingency Fund.

5. In the Government Order fourth read above, the Government have accorded provision of assistance to eligible beneficiaries of flood affected districts under Unemployed Youth Employment Generation Programme and also direct that all the eligible beneficiaries are exempted from undergoing Entrepreneurship Development Programme training under "Unemployed Youth Employment Generation Programme" in the flood affected districts.

6. The Government after careful examination of the proposal of the Industries Commissioner and Director of Industries and Commerce in para 4 above, accord sanction for a sum of Rs. 10,00,00,000/- (Rupees Ten crore only) towards individual based subsidy for the year 2015-16 for the beneficiaries of flood affected Districts under Unemployed Youth Employment Generation Programme

7. The amount sanctioned in para 6 above shall be debited to the following head of account :

**"2851-00. Village and Small Industries - 800 - Other Expenditure - Schemes in the Twelfth Five Year Plan - II State Plan - JB. Scheme for implementation of Unemployed Youth Employment Generation Programme - 11 Subsidies - 01 Individual based subsidy".**

8. Necessary additional funds will be provided in FMA 2015-16. The Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in Para 6 above after issue of FMA 2015-16.
