From the Industries Commissioner and Director of Industries and Commerce letter No.583/SK/2019, dated 06.09.2019.

Order:

The Principal Secretary / Industries Commissioner and Director of Industries and Commerce has informed that the Chemical Testing and Analytical Laboratory, Guindy building, Chennai was worst affected during the flooding of December 2015 deluge, the entire building was submerged under water upto 12 feet and damaged the windows and doors heavily. White washing and colour washing and other repairs were not carried out after the flood of December 2015. The roof of main building and MML building are in damaged condition, which causes water leakage in the roof during rainy season. The water pipe lines in Lab I and Lab II and overhead tank are highly corroded, which needs immediate repairing. Hence he has suggested that repairing of the buildings is highly essential to safeguard and maintain the Chemical Testing and Analytical Laboratory buildings.

2. He has further stated that no funds were sanctioned for the maintenance and other works after the flood of December 2015. In order to repair the damaged doors and windows, roof of main building and MML buildings, water pipe lines of Lab I and Lab II toilet block, the Principal Secretary/ Industries Commissioner and Director of Industries and Commerce has obtained a detailed estimate from PWD at the cost of Rs.51,00,000/-.

3. In view the above, the Principal Secretary / Industries Commissioner and Director of Industries and Commerce has requested the Government to sanction a sum of Rs.51,00,000/- (Rupees Fifty one lakhs only) for the renovation and special repairs to

water supply and sanitary arrangements, bore well and other repairs in Chemical Testing and Analytical Laboratory, Guindy, Chennai-32.

4. The Government after careful examination of the proposal of Industries Commissioner and Director of Industries and Commerce accord sanction for a sum of Rs.51,00,000/- (Rupees Fifty one lakhs only) for the renovation and special repairs to water supply and sanitary arrangements, bore well and other repairs in Chemical Testing and Analytical Laboratory, Guindy, Chennai-32.

5. The amount sanctioned in para 4 above shall be debited to the following head of account:-

2851 - 00 - VILLAGE AND SMALL INDUSTRIES - 102 - Small Scale Industries - State's Expenditure - AA - Chemical Testing and Analytical Laboratory, Chennai - 318 - Maintenance - 02 - Special Maintenance.

(IFHRMS - DPC: 2851 - 00 - 102 - AA - 318 - 02)

(Old DPC = 2851- 00 - 102 - AA - 18 22).

6. Necessary additional funds of Rs.51,00,000/- (Rupees Fifty One Lakh only) will be provided in FMA 2019-2020 to meet the expenditure sanctioned in para 4 above. However, this expenditure shall be brought for the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2019-2020. Pending provision of such funds, the Principal Secretary / Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in para 4 above after deducting Income Tax and Educational Cess thereon under proper acknowledgement. The Principal Secretary/ Industries Commissioner and Director of Industries and Commerce is also directed to include this item of expenditure while sending the budget proposal for FMA 2019-2020 and also send necessary draft explanatory note for inclusion of this expenditure in the Final Supplementary Estimate 2019-2020 to Government in Finance (Ind.) Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance (Industries) Department vide its U.O. No.710/2020, dated 23.01.2020 and ASL No.2895 (Two thousand eight hundred and ninety five).
