### **ORDER:**

During the review of Micro, Small and Medium Enterprises Department taken by the Hon'ble Chief Minister on 14.7.2011, the Hon'ble Chief Minister directed that a sum of Rs.1,00,00,000/- be provided as an annual recurring grant to Entrepreneurship Development Institute for meeting faculty cost and other administrative expenditure. Accordingly, in the Government Order first read above, the Government have sanctioned a sum of Rs.1,00,00,000 to Entrepreneurship Development Institute, towards Establishment and Administrative Expenses for the year 2011-12.

2. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce in his letter second read above has requested the Government to sanction a sum of Rs.1,00,00,000/- to Entrepreneurship Development Institute towards Establishment and Administrative expenses for the year 2014-15.

3. The Government after careful examination of the proposal of the Industries Commissioner and Director of Industries and Commerce, accord sanction for a sum of Rs.42,50,000/- (Rupees Forty two lakhs and fifty thousand only) as grant of first instalment to Entrepreneurship Development Institute towards meeting its establishment and administrative expenses for the year 2014-15.

4. The amount sanctioned in para 3 above shall be debited to the following head of account:

**“2851-00-Village and Small Industries - 102 Small Scale Industries – Schemes in the Twelfth Five Year Plan – II State Plan - ME Grants to Entrepreneurship Development Institute – 09 Grants in Aid – 01 Grants for Current Expenditure”.**
