1. G.O.(Ms) No. 03, Micro, Small and Medium Enterprises (E) Department, dated 20.02.2018.
2. From the Principal Secretary / Industries Commissioner and Director of Industries and Commerce, Letter Rc.No.3152/CW7/2017, dated 14.09.2018

Order:

In the Government Order first read above Government have sanctioned an amount of Rs.90.00 lakhs (Rupees Ninety lakhs only) for procuring sophisticated testing instruments for testing of metal and metallic products for Chemical Testing and Analytical Laboratory, Chennai and Regional Testing Laboratory, Madurai under TANII for the year 2017-2018.

2. Government have sanctioned an amount of Rs.90.00 lakhs under Tamil Nadu Innovation Initiatives (TANII) during 2017-18 to procure optical Emission Spectrometer under the head of account "2851-00-MX-1913" which includes provision of Rs.7.00 lakhs at Rs. 3.50 lakhs per Laboratory for civil and electrical works for the two laboratories and Rs.1.00 lakh to meet the advertisement charges. However, the above head of account namely, 2851-00-MX-1913 is meant only for the procurement of equipment and its accessories.

3. In the letter second read above, the Principal Secretary/ Industries Commissioner and Director of Industries and Commerce has requested the orders of the Government

1) To provide an amount of Rs.9.00 lakhs sanctioned as per the G.O. under the Revenue Expenditure outlay to carry out civil and electrical works for installation of Optical Emission Spectrometers and Air Conditioners (2 nos. per laboratory) at Chemical Testing and Analytical Laboratory, Chennai and Regional Testing Laboratory, Madurai under the following head of account:

"2851-00-102-MX-0909"

2) To allocate an amount of Rs.1.00 lakh sanctioned for advertisement as per the G.O. under the Revenue Expenditure outlay under the following head of account.

"2851-00-102-MX-0818"

3) To retain a sum of Rs.80 lakhs sanctioned for the procurement of equipment and its accessories under the following Head of Account:

"2851-00-102-MX-1913"

4. The Government after careful consideration has decided to accept the above proposal of Industries Commissioner and Director of Industries and Commerce accordingly sanction a sum of Rs.10,00,000/- (Rupees Ten lakh only) is re-appropriated and permit to utilize the fund allotted under the head of account from 2851-00-102 MX 19 01. Purchase to 2851 00 102 MX 19 03. Maintenance (Rs.9.00 lakh) and 2851 00 102 MX 08 01. Advertisement Charges (Rs.1.00 lakh).

5. The amount sanctioned in para-4 shall be debited to following Head of Account:-

"2851 00 Village and Small Industries – 102 Small Scale Industries - State's Expenditure – MX Purchase of sophisticated testing instrument for testing of Metal and Metallic Products under State Innovation Fund.

6. Necessary funds of Rs.10.00 lakh (Rupees Ten Lakh only) will be provided in RE / FMA 2018-2019. Pending provision of such funds in RE / FMA 2018-2019 by way of re-appropriation the funds from the Head of Account 2851 00 102 MX 19 01. Purchase. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the totally amount sanctioned in para 4 above and he is directed to include the above item of expenditure while sending the budget proposal for RE / FMA 2018-2019 to Finance (Industries) Department at the appropriate time without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.56737 / Ind / 2018 dated 27.12.2018 with ASL No. 2344. (Two thousand three hundred and forty four).
