In the said Rules, in the Annexure, (referred to in rule 4 (b)), for the entries in column (3), against the category "Assistant Director of Industries and Commerce (Survey and Statistics)" in column (1) and the method of appointment "Direct Recruitment" in column (2) thereof, the following entries shall be substituted, namely:-

"Master's degree in Statistics or Mathematics or Economics".
