ORDER:

In the Government Orders first and second read above, orders have been issued revising the rate of testing fees prescribed for various samples undertaken for testing by Chemical Testing and Analytical Laboratory, and Mechanical and Metallurgical Laboratory, Guindy and Regional Testing Laboratories at Madurai, Coimbatore, Salem and Thoothukudi for two years with effect from 22.12.2017. Item-wise analysis were also made for the revision of existing testing fees schedule prescribed in the said G.O (D) No.26, Micro, Small and Medium Enterprises (E) Department, dated 26.02.2018 by considering the following factors:-

- 1. Time consumption for doing the test
- 2. Increase in cost of chemicals
- 3. Man power involved
- 4. Cost of Service and Calibration of the instrument.

- 2. In the letter 3rd read above, the Industries Commissioner and Director of 2. In the letter 3rd read above, the industries and Commerce has requested the Government to issue orders on the following:
 - a) To extend the existing testing fee rates till 31.03.2020. a) To extend the existing less rates that the proposal of revision of schedule of testing fees with increase b) To approve the proposal of revision of schedule of testing fees

of 5% on all items in the existing rate of testing fees.

- or 5% on all liems in the existing fees shall take effect for the period of two years from 01.04.2020 to 31.03.2022.
- 3. The Government after careful consideration of the proposal of the Industries Commissioner and Director of industries and Commerce, extend the existing fee rates till 31.03.2020 and permit the Industries Commissioner and Director of Industries and Commerce to revise the testing fee rates at 5% per annum automatically on 1st April of the every Financial Year for the samples taken by Chemical Testing and Analytical Laboratory, Guindy and Regional Testing Laboratories, Madurai, Coimbatore Salem and Thoothukudi.
- 4. This order issues with the concurrence of Finance Department vide its U.O. No.8377/Finance(Ind)/2020, dated 13.03.2020.
