### **ORDER:**

The Government of India in their letter first read above conveyed the final approval for setting up of Common Facility Centre in Rice Mill Cluster, Alangulam, Tirunelveli District under Micro and Small Enterprises – Cluster Development Programme at a total project cost of Rs.787.00 lakh with the following pattern of funding:

2. In the Government Order second read above, the Government have sanctioned a sum of Rs.55,23,000/- (Rupees Fifty Five lakh and twenty three thousand only) being first instalment towards State Government contribution for setting up of Common Facility Centre in Rice Mill Cluster, Alangulam, Tirunelveli District.

3. The Government of India in their letter third read above, released a sum of Rs. 2,20,10,000/- being first instalment for the above cluster as their share.

4. The Tamil Nadu Small Industries Development Corporation Limited in its letter fourth read above has requested the Government to sanction Rs.23,68,000/- being balance grant of State Government Contribution to the Rice Mill Cluster, Alangulam, Tirunelveli District.

5. The Government after careful examination accept the proposal of Tamil Nadu Small Industries Development Corporation Limited and accord sanction a sum of Rs.23,68,000/- (Rupees Twenty three lakh and sixty eight thousand only) being balance grant of the State Government's contribution for setting up of Common Facility Centre for Rice Mill Cluster, Alangulam, Tirunelveli District under Micro and Small Enterprises – Cluster Development Programme.

6. The amount sanctioned in Para 5 above shall be debited to the following head of account:

**“2851-00 Village and Small Industries - 102. Small Scale Industries - Schemes in the Twelfth Five Year Plan – II . State Plan - MG Provision of Common facilities for Small Industries Cluster Development Programme 09. Grants- in-aid- 02. Grants for creation of capital assets.”**

7. Necessary funds will be provided in RE/FMA 2015-16. Pending provision of such funds, the Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in Para 5 above to Tamil Nadu Small Industries Development Corporation Limited. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2015-16. The Industries Commissioner and Director of Industries and Commerce is directed to send necessary draft explanatory notes for inclusion of this expenditure in the supplementary Estimates 2015-16 and include this expenditure while sending proposal for RE/FMA 2015-16 to Government in Finance (Ind /BG-I) Department without fail.
