ORDER:

In the G.O. 1st and 2nd read above, the Government have sanctioned the post of Assistant Director of Industries and Commerce (Salt) in the Department of Industries and Commerce. In the G.O.3rd and 4th read above, the Government have issued orders for permanent retention of the said posts.

2. In the G.O 5th read above, the Government have framed the Adhoc Rules to the post of Assistant Director of Industries and Commerce (Salt). In the G.O.6th read above, the Government have amended the Adhoc Rules for the post of Assistant Director of Industries and Commerce (Salt) included in category 3 of Tamil Nadu Industries Service by making the post of Inspector (Salt) instead of Junior Analytical Chemists as a feeder post to the post of Assistant Director of Industries and Commerce (Salt) with service qualification of 10 years.

3. In the proposal 7th read above, the Principal Secretary / Industries Commissioner and Director of Industries and Commerce has sent a proposal of draft amendment to Government for codification for the post of Assistant Director of Industries and Commerce (Salt) in the Special Rules for Tamil Nadu Industries Service for incorporating the revised adhoc rules for the post of Assistant Director of Industries and Commerce (Salt).

4. The Government have examined the proposal of the Principal Secretary / Industries Commissioner and Director of Industries and Commerce in detail and decided to accept it. Accordingly, the Government amend the Special Rules for Tamil Nadu Industries Service.

5. The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the rules published with Industries Department Notification No.SRO.B.455/79, dated 3rd September 1979 at pages 556-558 of Part-III Section 1(b) of the Tamil Nadu Government Gazette, dated the 10th October, 1979, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Industries Service (Section 19 of Part III- A of the Special Rules for the State Services in Volume-II of the Tamil Nadu Services Manual, 2016).

AMENDMENTS.

In the said Special Rules,-

- (1) in rule 1, under the heading 'Category 3', after the expression 'Assistant Superintendent, CETL, Kakkalur', the expression "Assistant Director of Industries and Commerce (Salt)" shall be added;
- (2) in rule 2, in sub-rule (a), in the Table, after the expression 'Assistant Director of Industries and Commerce (Industrial Co-operatives)' in Column (1) and the corresponding entries relating thereto in column (2), the following expression shall be added namely:--

"Assistant Director of Industries and Commerce (Salt)	(1) by recruitment by transfer from among the holders of the post of Inspector (Salt) in the Tamil Nadu Industries Subordinate Service;
	(2) by direct recruitment;
	(3) by transfer from among the holders of the post of Assistant Director of Industries and Commerce / Superintendents / Senior Chemists in category 3 of the Tamil Nadu Industries Service";

- (3) in rule 4, in the first proviso to sub-rule(a), after the entry, "State Geologist" the entry "Assistant Director of Industries and Commerce (Salt) shall be added".
- (4) in ANNEXURE, after the expression 'Assistant Executive Engineer (Electrical) Industrial Estate, Guindy' in column (1) and the corresponding entries relating thereto in column (2) and (3) thereof, the following entries shall, respectively, be added, namely:--

"Assistant Director of Industries and Commerce (Salt)"

- (a) by recruitment by transfer from among the holders of the posts of Inspector (Salt) in the Tamil Nadu Industries Subordinate Services.
- (i) A degree in Chemistry or Industrial Chemistry; and
- (ii) Must have served as Inspector (Salt) in the Tamil Nadu Industries Subordinate Service for a period of not less than ten years;
- (b) by direct recruitment
- (i) A first or second class M.Sc., degree in Physical Chemistry or a first or second class B.Sc., degree in Metallurgy or a degree in Chemical Engineering; and
- (ii) Research and Practical experience in the analysis of Industrial Productions for a period of not less than three years;

Provided that, other things being equal, preference shall be given to candidates who possess all or any of the following additional qualifications, namely:-

- (1) Publication of Scientific papers;
- (2) Teaching experience in Chemistry at H.Sc., or its equivalent standard or higher standard for a period of two years from the Institution recognized by the Government. The above experience should be obtained after acquiring the prescribed educational qualifications and from an authority competent to issue such certificate".

- c) by transfer from among the holders of the posts of Assistant Director of Industries and Commerce / Superintendents / Senior Chemist in Category 3 of the Tamil Nadu Industries Service. Must possess a degree or diploma in Chemical Engineering and must be an approved probationer in Category 3 of the Tamil Nadu Industries Service.

(5) in rule 6, after the fifth proviso, the following proviso shall be added, namely:-

"provided also that a probationer in the category of Assistant Director of Industries and Commerce (Salt) shall within the period of his probation pass the following Tests, namely:-

- (i) Tamil Nadu Government Office Manual; and
- (ii) Account Test for Executive Officers (or) Account Test for Subordinate Officers, Part - I".
