ORDER:

In the letter read above, the Industries Commissioner and Director of Industries and Commerce has stated that, the following three technical educational Institutions are functioning under the control of Industries and Commerce Department.

i. Government Technical Training Centre, Guindy was established in the year 1962 and this institution is conducting the following diploma courses.

ii. Institute of Tool Engineering, Dindigal was established in the year 1961 and this institution is conducting the following technical courses.

2. The Industries Commissioner and Director of Industries and Commerce has also stated that, the above institutions were established nearly 50 years ago. Out of the three institutes, Institute of Tool Engineering, Dindugal and Institute of Ceramic Technology, Virudhachalam are located in backward areas to serve the needy. The students studying in these Institutions are trained well and most of the students get the job at the campus interview in the final year. Many of the students have got job abroad. In the present scenario of shortage of skilled man power, these institutions have become more relevant. The Industries Commissioner and Director of Industries and Commerce has been receiving reports from the Principals of these institutions to provide funds to upgrade the infrastructure in each of the technical institutions as per the AICTE norms. These requirements are mandatory in nature and there is a need to comply with norms without delay in order to obtain approval of AICTE. The above issue was discussed in detail during the review meeting by Hon'ble Chief Minister on 18.03.2012. Based on the discussion it was decided that, funds of Rs.3 crores may be provided to these three Institutions for upgradation of infrastructure during 2012-13.

3. The above proposals mainly provide for purchase of additional machineries, equipments, electrical cables, strengthening of existing labs, upgradation of libraries, construction of seminar halls, renovation of existing class rooms, drawing halls, machine work shops and construction of toilets. Institution wise breakup details are as follows:-

The Industries Commissioner and Director of Industries and Commerce has requested the Government to provide fund to the tune of Rs.3.00 Crores as grant to Government Technical Training Centre, Guindy, Institute of Tool Engineering, Dindigul and Institute of Ceramic Technology, Virudhachalam as mentioned in para 3 above.

5. The Government examined the proposal of Industries Commissioner and Director of Industries and Commerce in detail and accord sanction for a sum of Rs.3,00,00,000/- (Rupees Three crores only) for improvement of infrastructure facilities to Government Technical Training Centre, Guindy, Institute of Tool Engineering, Dindigul and Institute of Ceramic Technology, Virudhachalam as detailed in para 3 above.

9. The expenditure sanctioned in para 5 above constitutes an item of 'New Instrument of Service' and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund, orders in this regard will be issued by Finance (B.G.I) Department separately. The Industries Commissioner and Director of Industries and Commerce, Chennai-28 is requested to send necessary proposals to Government in Finance (BG-I) Department in the prescribed format along with a copy of this order for sanction of an advance from the contingency fund. He is also requested to send necessary explanatory note to Finance (BG.I) Department to include this item of expenditure in the Supplementary Estimates 2012-2013 at the appropriate stage.

10. The Industries Commissioner and Director of Industries and Commerce shall ascertain the requirements of funds and apply for Contingency Fund advance for the works indicated at para 3 above.




