Order:

The Principal Secretary/Industries Commissioner and Director of Industries and Commerce has informed that the Institute of Ceramic Technology, Vridhachalam was established in the year 1964 and is offering Diploma in Ceramic Technology course of 3½ years duration. This institute is approved by the AICTE. Sanctioned intake of students for 1 year admission is 50. In the II year, maximum of 10 students can be admitted, including the vacancies in the I year under the Lateral Entry scheme. About 170 students are studying in the Institute and this is the only institution offering Diploma in Ceramic Technology course in the state of Tamil Nadu.

2. Further he has stated that the Institute of Ceramic Technology had the hostel facility since 1968 which attracted students from all the districts of Tamil Nadu as well as from other states, whereas the hostel at present is in highly dilapidated condition. The Institute hostel was constructed in 1968. The hostel was closed due to its poor structural condition in 2008. The students from long distance are finding it difficult to join the course due to the non availability of hostel facilities. In the absence of a good hostel, the Institute is not in a position to attract better students from far off districts as

well as other states. Therefore, it is needed to rebuild / establish a suitable hostel facility for the students of Institute of Ceramic Technology, Vridhachalam.

- 3. In G.O (Ms) No.21, Micro, Small and Medium Enterprises (C) Department, dated 20.07.2018, the Government have issued orders to transfer the Ceramic Industrial Estate, Vridhachalam currently under the control of Industries Commissioner and Director of Industries and Commerce to Tamil Nadu Small industries Development Corporation on "as is where is condition". While handing over, an area of 2.4 acres of old hostel building along with open area for play ground in the Ceramic Industrial Estate was retained for the construction of New Hostel for the Institute of Ceramic Technology.
- 4. The Industries Commissioner and Director of Industries and Commerce has also stated that the Principal, Institute of Ceramic Technology, Vridhachalam submitted the estimate received from Public Works Department for the construction of new hostel building for 50 students of Institute of Ceramic Technology, Vridhachalam with provision for the Compound Wall (331 RM), approach road, Rain water Harvesting, Fire Fighting arrangements and new bore well for an amount of Rs.165 lakhs for the year 2019-2020.
- 5. The Industries Commissioner and Director of Industries and Commerce has requested the Government to provide necessary funds for the tune of Rs.165 Lakhs for the year 2019-2020 for the construction of new hostel for the students of Institute of Ceramic Technology at Vridhachalam,
- 6. The Government after careful examination of the proposal of the Industries Commissioner and Director of Industries and Commerce, accord sanction for a sum of Rs.165.00 Lakhs (Rupees One hundred and sixty five lakhs) for the construction of new hostel for the students of Institute of Ceramic Technology at Vridhachalam.
- 7. The amount sanctioned in para 7 above shall be debited to the following head of account:-

"4059 Capital Outlay on Public Works -01 Office Buildings - 051. Construction - State's Expenditure - KZ Industries and Commerce Department - 416. Major works - 01. Major Works.(DPC 4059-01-051-KZ-41601)".
