ORDER:

In the Government Order first read above, the Government have approved the Unemployed Youth Employment Generation Programme and issued order to implement the scheme from the year 2010-11 onwards.

2. In the Government Order second read above, the Government have sanctioned a sum of Rs.7,03,90,625/- (Rupees Seven crore three lakh ninety thousand six hundred and twenty five only) as 1st instalment towards implementation of Unemployed Youth Employment Generation Programme for the year 2014-2015.

- 3. In the Government Order third read above, the present rate of subsidy has been enhanced from 15% to 25% of the project cost. Similarly, the maximum subsidy amount has been enhanced from Rs.75,000/- to Rs.1,25,000/- per beneficiary under Unemployed Youth Employment Generation Programme (UYEGP).
- 4. In the Government Order fourth read above, the Government have sanctioned a sum of Rs.3,51,95,312/- (Rupees Three crore fifty one lakh ninety five thousand three hundred and twelve only) as second instalment towards implementation of Unemployed Youth Employment Generation Programme for the year 2014-2015.
- 5. In the Government Order fifth read above, the Government have sanctioned a sum of Rs.8,78,60,500/- (Rupees Eight crore seventy eight lakh sixty thousand five hundred only) towards implementation of Unemployed Youth Employment Generation Programme for the year 2014-15.
- 6. In the Government Order sixth read above, the Government have sanctioned a sum of Rs.3,52,75,212/- (Rupees Three crore fifty two lakh seventy five thousand two hundred and twelve only) towards implementation of Unemployed Youth Employment Generation Programme for the year 2014-15 and 2015-16 as first and second quarter amount.
- 7. The Industries Commissioner and Director of Industries and Commerce has requested the Government to sanction a sum of Rs..1449.03 crore under Unemployed Youth Employment Generation Programme as second instalment for the year 2015-16 as follows:
