### **ORDER:**

The scheme “Unemployed Youth Employment Generation Programme” was approved in the Government Order first read above.

2. In the Government Order fourth read above, the Government have sanctioned a sum of Rs. 7,79,41,500/- as first instalment towards the implementation of the “Unemployed Youth Employment Generation Programme” for the year 2013-14.

3. In the Government in G.O. 5<sup>th</sup> read above, the Government have sanctioned for a sum of Rs.8,76,83,500/- as second instalment towards implementation of UYEGP Scheme during the year 2013-14.

4. In the letter sixth read above, the Principal Secretary / Industries Commissioner and Director of Industries and Commerce has stated that during the year 2013-14 under UYEGP scheme, 5311 candidates were trained by the Entrepreneurship Development Institute, Chennai and total institutional training fee for 5311 candidates is Rs.47,79,900/- (Rupees Forty seven lakh seventy nine thousand and nine hundred only). Out of this, a sum of Rs.28,95,250/- has been settled during 2013-14.

5. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce has requested the Government to sanction a sum of Rs.18,84,650/- (Rupees Eighteen lakh eighty four thousand six hundred and fifty only) towards settlement of pending Institutional Training Fee to Entrepreneurship Development Institute under UYEGP Scheme for the year 2013-14.

6. The Government, after careful consideration of the proposal of the Industries Commissioner and Director of Industries and Commerce in para 5 above, accord sanction for a sum of Rs.18,84,650/- (Rupees Eighteen lakh Eight four thousand six hundred and fifty only) towards settlement of pending Institutional Training Fee to Entrepreneurship Development Institute under UYEGP Schemes for the year 2013-14 out of the budget provisions made in BE 2014-15.

7. The amount sanctioned in para 6 above shall be debited to the following head of account.
