**ORDER:**

The Government vide letter dated 12.06.2012, forwarded the proposal of setting up of Common Facility Centre for Gate and Grill Cluster, Thirumullaivoyal, Thiruvallur District to the Government of India with the following funding pattern for placing before the Steering Committee for Micro and Small Enterprises - Cluster Development Programme for approval.

2. The Government of India in their letter 3<sup>rd</sup> cited have conveyed their final approval for setting up of Common facility Centre for Gate and Grill Cluster, Thirumullaivoyal, Thiruvallur District under MSE-CDP with the following revised funding pattern.

The Tamil Nadu Small Industries Development Corporation Limited has requested the Government to sanction Rs.29.69 lakh towards 1<sup>st</sup> instalment of State Government contribution for setting up of Common Facility Centre for Gate and Grill Cluster at Thirumullaivoyal, Tiruvallur District under Micro and Small Enterprises - Cluster Development Programme.

4. The Government after careful examination of the proposal of Tamil Nadu Small Industries Development Corporation Limited accord sanction for a sum of Rs.20,78,000/- (Rupees Twenty lakh seventy eight thousand only) being the first instalment for setting up of Common Facility Centre for Gate and Grill Cluster at Thirumullaivoyal, Tiruvallur District under Micro and Small Enterprises – Cluster Development Programme.

He is also directed to send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2015-16.
