



ABSTRACT

Micro, Small and Medium Industries Policy, 2008 – Inclusion of Hydraulic cylinder as a component eligible for Special Capital Subsidy in Annexure-7 and the line of activity of Low tension and High tension Electrical Motor Coil as an additional item in Annexure-6 – Amendment to Micro, Small and Medium Industries Policy, 2008 and Guidelines for Administration of Incentives and Concessions – Orders – Issued.

ORDER:

In the Government Order first read above, the Government have announced the Micro, Small and Medium Industries Policy, 2008 for the development of Micro, Small and Medium Enterprises in Tamil Nadu besides announcing certain incentives and concessions, in which an illustrative list of items eligible for subsidy has been listed in Annexure-7. Provision has also been made therein at item No. 187 to include any other item at a later date in the list.

2. In the Government Order second read above, the Government have issued amendment to the Government Order first read above for inclusion of "Steering knuckles LH and Steering knuckles RH" as an automobile component eligible for subsidy by assigning serial No. 187 in Annexure-7 in the list of Automobile Parts/Components eligible for Special Capital Subsidy under Thrust sector.

3. The Industries Commissioner and Director of Industries and Commerce in his proposal has stated that a representation has been received for inclusion of the item "Hydraulic Cylinder" in the list of Automobile Parts / Components eligible for Special Capital Subsidy and to include "Hydraulic Cylinder" as an automobile component assigning serial number 188 in Annexure II of the G.O. (Ms.) No. 14, Micro, Small and Medium Enterprises (B) Department dated 07.05.2008 under the caption "Guidelines for Administration of Incentives and Concessions in the Policy" in Annexure-7.

4. The Industries Commissioner and Director of Industries and Commerce has further stated that the General Manager, District Industries Centre, Erode has informed that M/s. Coral Coil India Private Limited, Erode is engaged in and the line of activity of Manufacture of "Low tension and High Tension Electrical Motor Coil" with date of commencement of production as 12.10.2014 and has applied for capital subsidy on 28.05.2015. In the illustrative list of electrical items eligible for Capital Subsidy Annexure-6, the activity of "Low tension and High tension electrical motor coil" is not included. Hence the General Manager, District Industries Centre, Erode has requested to clarify the eligibility based on the representation received in this regard.

5. The Department of Automobile Engineering, Madras Institute of Technology Campus, Anna University, Chennai has confirmed that "Hydraulic Cylinders are one of the automotive components of heavy and medium Vehicle such as waste collection trucks, front end loaders, sprayers, tractors and various other mobile agricultural equipments. These Hydraulic Cylinders are an integral and critical part of these above mentioned Automobile equipments"

6. The Department of Electrical and Electronics Engineering, Anna University, Chennai also opined that " Subsidy can be considered to be given for the production line of both the low tension and high tension motor coils subject to condition that the copper losses and therefore the efficiency of these motors manufactured for all frame sizes should strictly meet the energy efficiency of standards as prescribed by the International Electrotechnical Commission(IEC) standards of atleast IE2 class and the correctness of the same shall be ascertained by a certified testing agency"

7. In the reference third read above, the Industries Commissioner and Director of Industries and Commerce has requested to issue necessary amendment for inclusion of the item "Hydraulic Cylinder" in the list of Automobile Parts/Components assigning serial number 188 in Annexure II under the caption "Guidelines for Administration of Incentives and Concessions in the Policy" in Annexure 7, and the line of activity of Low tension and High tension Electrical Motor Coil as an additional item No. 19 in sub-head III. Industrial in Annexure 6-A Electrical items Eligible for subsidy of the Guidelines for Administration of incentives and concessions (Annexure-II) so as to make them eligible for

special capital subsidy and also requested to delegate him with the powers to include any electrical and electronics items / automobile parts / components which are being manufactured by Micro, Small and Medium Enterprises in the eligible list mentioned in Annexure-6 and Annexure-7 of the Government Order first read above.

8. The Government, after careful examination, have decided to accept the proposal of the Industries Commissioner and Director of Industries and Commerce and issue the following amendment to the Government Order first read above which shall take effect from the date of issue of this order :-

Amendment to Micro, Small and Medium Industries Policy, 2008

A. In the Government Order first read above, in Annexure II of under the caption "Guidelines for Administration of Incentives and Concessions in the Policy" in Annexure-7, relating to "Automobile Parts / Components eligible for Special Capital Subsidy" after the existing item at Sl.No.188 under the sub-heading "Miscellaneous" the following shall be added:-

188-"Hydraulic Cylinder"

Sl.No.188 found in the existing Sl.No. shall be renumbered as 189.

B. In the Government Order first read above in Annexure II under the caption "Guidelines for Administration of Incentives and Concessions in the Policy" in Annexure-6-A, under the heading "list of Electrical items eligible for Subsidy" under the sub- heading "A. List of Electrical items eligible for subsidy" under "III INDUSTRIAL" after existing item at Sl. No. 19, the line of activity of Low tension and High tension Electrical Motor Coil shall be added.

9. This order issues with the concurrence of Finance department vide its U.O.No.62169/Ind/2018, dated 20.12.2018.
