ORDER:

In order to provide skilled human resource required by existing MSME units as well as the new units and to create employment opportunities, orders were issued in the G.O first read above for the implementation of Amma Skill Training and Employment Scheme based on the announcement made by the Hon'ble Chief Minister during Budget session under Rule 110 of Tamil Nadu Legislative Assembly on 24.07.2014. In the said order, the Government have issued 12 modalities to be followed for the successful implementation of the scheme and one of them is that the Scheme will be run under the existing budgeted scheme of Tamil Nadu Skill Development Corporation. Under this scheme, MSMEs will have to give employment based job oriented training for the candidates. In the Government order second read above, the Government have issued detailed guidelines for the implementation of Amma Skill Training and Employment Scheme.

2. In the Government order 3rd read above orders have been issued for the continuation of Amma Skill Training and Employment Scheme during the year 2019-20.

3. In the letter 4th read above, the Industries Commissioner and Director of Industries and Commerce has informed that the “Amma skill Training and Employment Scheme” for the year 2019-20 was implemented throughout the State through District Industries Centre in the respective districts. Under this scheme, for the year 2019-20, 25,257 candidates have been trained as against the target of 25,000 candidates and

has therefore requested the Government to issue necessary Government Order for continuation of the "Amma Skill Training and Employment Scheme" during the year 2020-21, indicating the target of 25,000 candidates for the year 2020-21, so as to enable them to send necessary communication to all General Managers, District Industries Centres for implementation. p-32

4. The Government after careful examination of the proposal of the Industries Commissioner and Director of Industries and Commerce decided to accept it and accordingly issue orders for the continuation of "Amma Skill Training and Employment Scheme" for the year 2020-21, based on the fund available with Tamil Nadu Skill Development Corporation.
