- f) District level Award for Best Entrepreneur.
- 2. In the Government Order second read above, orders have been issued for constitution of Committees for selection of Hon'ble Chief Minister's awards for best-performing entrepreneurs and banks that service the Micro, Small and Medium Enterprises Department sector and lays down criteria for such selection as well as the marks to be assigned for such selection. Accordingly, the State Level and District Level awards to the Best Entrepreneurs and the Banks have been distributed upto the financial year 2018-19.

- 3. Based on the suggestions of the members of the committee and detailed discussions, the Industries Commissioner and Director of Industries and Commerce in the references third cited has proposed to revise certain conditions laid down in the Government Order second read above and accordingly submitted a revised draft guideline for approval of the Government.
- 4. The Government after careful examination of the proposal of the Industries Commissioner and Director of Industries and Commerce has decided to accept and accordingly issue "Revised Guidelines for Processing of Award Application" as annexed to this Order for evaluation of the awards from the Financial Year 2019-2020 onwards.

Revised Guidelines for processing award applications

1. Objective: The Micro Small and Medium Enterprises sector is the engine of growth in the State and a major contributor to employment and balanced regional growth. Considering the importance of the sector and the need to encourage the enterprises who have excelled on various parameters the Government have instituted the Annual Chief Minister's Award for Micro, Small and Medium Enterprises and Banks.

2. Categories of Awards: -

- i. State Level Award for Best Agro-Based Industry
- ii. State Level Award for Best Woman Entrepreneur
- iii. State Level Award for Best Entrepreneur
- iv. State Level Award for Best QUALITY and EXPORTS
- v. District Level Award for Best Entrepreneur
- vi. State Level Award for Best Performing Bank (1st Prize, 2nd Prize and 3rd Prize)
- **3. Selection Committee**: In G.O. (Ms.) No.3, Micro, Small and Medium Enterprises (A) Department, dated 09.01.2014, the Government have also constituted committees for selecting the Best Entrepreneur/Bank and the same shall be constituted as follows:

- **4. Criteria of Evaluation:** The criteria for evaluation of the applications received online for the relevant award will be scrutinised based on the following guidelines
 - a. State Level /District Level Best Entrepreneur Award Annexure I
 - b. State Level Best Woman Entrepreneur Award Annexure II
 - c. State Level Best Quality and Export entrepreneur Award Annexure-III
 - d. Guidelines for the State Level Agro-Based Industries Annexure IV
 - e. State Level Best Banker Award Annexure-V

The applications received online will be forwarded by the General Manager concerned / Regional Joint Director, Chennai with their recommendations and will be scrutinised subsequently by the Pre-scrutiny Committee as above. These scrutinised applications will then be placed before the State Level Selection Committee for selection.

5. Periodicity and Eligibility: The Micro, Small and Medium Enterprises should have been in continuous production for the previous three years. The awards will be given for each year to deserving Micro, Small and Medium Enterprises which have been registered with UDYAM Registration Certification.

To encourage more number of enterprises "The Awardee shall not be nominated or considered for the same or lower category of award in the subsequent 5 year(s). However, there will be no bar for an awardee to be nominated or considered for a higher category of award in the subsequent year".

- **6. How to apply:** The eligible enterprises and the banks will submit their applications online as per the advertisement released by the Industries Commissioner and Director of Industries and Commerce in leading newspapers for the relevant year and category of awards. An enterprise can apply for more than one category online provided that the condition Stated above is fulfilled.
- **7. Applicability of the Guidelines**: The above guidelines will be applicable for the selection of awards from the financial year (2019-20).
