ORDER:

The Hon'ble Minister for MS&ME, while moving the demand No.44 for the year 2022-2023 among others, made the following announcement :-

"கரூர் மாவட்டம், க.பரமத்தி வட்டாரத்தில் சுமார் 700 தொழிலாளர்களுடன் இயங்கி வரும் 60 கயிறு தொழில் நிறுவனங்களில், 15 கயிறு தொழில் நிறுவனங்கள் பயன் பெறும் வகையில், கயிறு மிதியடிகள் மற்றும் தரை விரிப்புகள், இரு பிரி கயிறு மற்றும் தென்னை நார்வலை ஆகிய மதிப்பு கூட்டப்பட்ட ஏற்றுமதி சார் பொருட்களின் உற்பத்தியை ஊக்குவிக்கும் வகையில், ரூ.5 கோடி தமிழ்நாடு அரசு பங்களிப்புடன், ரூ.6.93 கோடி திட்ட மதிப்பீட்டில், ஒரு கயிறு குழும பொது வசதி மையம் நிறுவப்படும்".

2. Based on the above announcement, the Industries Commissioner and Director of Industries and Commerce has submitted the proposal to Government for the formation of Coir Cluster Common Facility Centre in the name of M/s.Cauvery Coir Producer Company Limited at Anjur Village, K.Paramathi Block (Backward Block), Pugalur Taluk, Karur District as detailed below:-

Coir is one of the agro based industries gaining prominence in the Karur District. Coir Fibre extraction and Yarn spinning are major activities undertaken in the District. The proposed coir cluster covers the Blocks of Karur, K.Paramathi, Aravakurichi, Thanthonimalai and Krishnarayapuram in Karur District. This Cluster will be established with 16 units as Special Purpose Vehicle namely M/s.Cauvery Coir Producer Company Limited. The Special Purpose Vehicle has identified the land to an extent of 2.50 acres for establishing the Coir Cluster Common Facility Centre at S.No.597/2A, Anjur Village, K.Paramathi Block (Backward Block), Pugalur Taluk, Karur District and requested the Government to issue orders on the following:-

- a) Setting up of Coir Cluster Common Facility Centre in the name of M/s. Cauvery Coir Producer Company Limited at Anjur Village, K.Paramathi block (Backward Block), Pugalur Taluk, Karur District at an estimated cost of Rs.6.93 Crore shared by both the Government of Tamil Nadu and the Special Purpose Vehicle.
- b) Sanction a sum of Rs.5.00 Crore as Government of Tamil Nadu Grant towards implementation of the project under a New Head of Account

3. After careful examination of the request of the Industries Commissioner and Director of Industries and Commerce, the Government approve the proposal for setting up of Coir Cluster Common Facility Centre in the name of M/s. Cauvery Coir Producer Company Limited at Anjur Village, K.Paramathi block (Backward Block), Pugalur Taluk, Karur District at an estimated cost of Rs.6.93 Crore shared by both the Government of Tamil Nadu (Rs.5.00 Crore) and the Special Purpose Vehicle (Rs.1.93 Crore). Accordingly, Government sanction a sum of Rs.5.00 crore (Rupees Five crore only) as Government of Tamil Nadu Grant towards implementation of the project in the name of M/s. Cauvery Coir Producer Company Limited, Karur District.

4. The amount sanctioned in Para 3 above shall be debited to the following new head of account:

"2851 - 00 - Village and Small Industries 106 - Coir Industries
- State's Expenditure - AD - Establishment of Coir Cluster
Common Facility Centre at Karur District - 309 - Grants-in-
Aid-03 Grants for specific schemes"

5. The expenditure sanctioned of Rs.5,00,00,000/- in para 3 above shall constitute an item of "New Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Industries Commissioner and Director of Industries and Commerce is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Industries Commissioner and Director of Industries and Commerce shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (BG-I / Industries) Department at an appropriate time without fail.

6. The Industries Commissioner and Director of Industries and Commerce is the Estimating, Reconciling and Controlling Authority for the above said New Head of Account. The Pay and Accounts Officer / Treasury Officer concerned are directed to open the above new Head of Account in their books.

7. The Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in para 3 above to the Special Purpose Vehicle and to send the Utilization Certificate to the Government in this regard.

8. This order issues with the concurrence of Finance Department vide its U.O. No.406/ADS(G.K.T)/2022, dated 18.08.2022 with ASL No.0994 (Nine Hundred and Ninety Four) (IFHRMS ASL No.2022080994).
