The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Industries Service (Section 19 of Part III-A of the Special Rules for the State Services in Volume II of the Tamil Nadu Services Manual, 2016).

2. The amendments hereby made shall come in to force on the 20th September 2017.

AMENDEMENTS

In rule 4 (b) of the said Special Rules, in the Annexure, for the entries in column (3), against the category "Senior Chemist" in column (1) and the method of appointment "Direct recruitment" in column (2) thereof, the following entries shall be substituted, namely:-

1. A Post Graduate degree in Chemistry or Industrial Chemistry or an Associateship Diploma of the Institute of Chemists (India); and
2. Practical experience in the Analysis of Industrial Products for a period of not less than 3 years:

Provided that other things are being equal, preference shall be given to the candidate who possess, in addition, all or any of the following qualifications:-

- (i) Publication of Scientific Papers
- (ii) Teaching experience in Chemistry at H.Sc or its equivalent standard or higher standard for a period of two years from the Institution recognized by the Government. The above experience should be obtained after acquiring the prescribed educational qualifications and from an authority competent to issue such certificate".
