1. Budget Speech of the Hon'ble Minister for MS&ME on 20-04-2022 for the year 2022-2023.
2. From the Industries Commissioner and Director of Industries and Commerce letter Rc. No.21850/ICC2/2021, dated 07.06.2022 and 01.08.2022.

ORDER:

The Hon'ble Minister for MS&ME, while moving the demand No.44 for the year 2022-2023 among others, made the following announcement :-

"திருப்பூர் மாவட்டம், குண்டாம் வட்டாரத்தில் சுமார் 3,000 தொழிலாளர்களுடன் இயங்கி வரும் 290 கயிறு தொழில் நிறுவனங்களில், 35 கயிறு தொழில் நிறுவனங்கள் பயன்பெறும் வகையில், சாயமிடப்பட்ட தென்னை நார் கயிறு, தென்னை நார் கயிறு ஊசி ஒட்டுக் கம்பளம், கயிறு மிதியடிகள் மற்றும் தரை விரிப்புகள் ஆகிய மதிப்பு கூட்டப்பட்ட ஏற்றுமதி சார்பொருட்களின் உற்பத்தியை ஊக்குவிக்கும் வகையில், ரூ.10 கோடி தமிழ்நாடு அரசு பங்களிப்புடன், ரூ.16 கோடி திட்ட மதிப்பீட்டில், ஒரு கயிறு குழும பொது வசதி மையம் நிறுவப்படும்".

2. Based on the above announcement, the Industries Commissioner and Director of Industries and Commerce has submitted a proposal to Government for the formation of Coir Cluster Common Facility Centre in the

name of M/s.Amaravathy Coir Producer Company Limited a SPV at Kundadam Block (Backward Block), Dharapuram Taluk, Tiruppur District at an estimated cost of Rs.13.95 Crore as detailed below:-

- a) Coir is one of the agro based industries gaining prominence in the Tiruppur District. Coir Fibre extraction and Yarn spinning are major activities undertaken in the Tiruppur District.
- b) The proposed coir cluster at Kundadam Block covers the Blocks of Kangeyam, Dharapuram, Udumalpet and Madathukulam in Tiruppur District. This Cluster will be established with 35 units as Special Purpose Vehicle.
- c) M/s.Amaravathy Coir Producer Company Limited, a SPV has identified the land to an extent of 4.65 acres for establishing the Coir Cluster Common Facility Centre at Kundadam Block (Backward Block), Dharapuram Taluk, Tiruppur District.
- d) The following common facilities are proposed for the Coir units in Tiruppur District to enhance raw material utility, value addition and marketability:-
 1. Coir Tufted mat.
 2. Coir Yarn Dyeing with Zero discharge ETP facility.
 3. Coir Matting manufacturing facility.
 4. Coir Needle felt (Non woven Geo-textiles) manufacturing facility.

3. The Industries Commissioner and Director of Industries and Commerce has requested the Government to issue orders for setting up of Coir Cluster Common Facility Centre in the name of M/s.Amaravathy Coir Producer Company Limited at Kundadam Block in Tiruppur District.

4. After careful examination of the request of Industries Commissioner and Director of Industries and Commerce, the Government issue orders for setting up of Coir Cluster Common Facility Centre in the name of M/s.Amaravathy Coir Producer Company Limited at Kundadam Block (Backward Block), Dharapuram Taluk, Tiruppur District at an estimated cost of Rs.13.95 Crore with the Government of Tamil Nadu grant of Rs.8.75 Crore and SPV contribution i.e., M/s.Amaravathy Coir Producer Company Limited of Rs.5.20 Crore. The Government also sanction a sum of Rs.8,75,00,000/- (Rupees Eight crore and Seventy Five lakh only) as Government of Tamil Nadu Grant towards implementation of the above project.

5. The amount sanctioned in Para 4 above shall be debited to the following new head of account:

"2851 - 00 - Village and Small Industries -106 - Coir Industries - State's Expenditure- AC - Establishment of Coir Cluster Common Facility Centre at Tiruppur District - 309 - Grants-in-Aid-03 - Grants for specific schemes"

6. The expenditure sanctioned of Rs.8,75,00,000/- in para 4 above shall constitute an item of "New Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Industries Commissioner and Director of Industries and Commerce is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.1) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.1) Department. The Industries Commissioner and Director of Industries and Commerce shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (BG-I/ Industries) Department at an appropriate time without fail.

7. The Industries Commissioner and Director of Industries and Commerce is the Estimating, Reconciling and Controlling Authority for the above said New Head of Account. The Pay and Accounts Officer / Treasury Officer concerned are directed to open the above new Head of Account in their books.

8. The Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in para 4 above to the SPV and to send the Utilization Certificate to the Government in this regard.

9. This order issues with the concurrence of Finance Department vide its U.O. No.408/ADS(GKT)/2022, dated 18.08.2022 with ASL No.0993 (Nine hundred and ninety three) (IFHRMS ASL No.2022080993).
