ORDER:

In the Government Order first read above, orders were issued allotting 1.91 acres of land in Alandur Village in T.S. No. 20/2, 21/2 and 22/2 in Block No. 2, Guindy Industrial Estate to the Entrepreneurship Development Institute on lease for 30 years on a nominal lease rent of Rs.1000/- per annum for construction of a Modern Training Complex.

- 2. In the Government Order second read above, the Government have sanctioned a sum of Rs.4.88 crores for construction of Modern Training Complex of the Entrepreneurship Development Institute.
- 3. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce has stated that the Director, Entrepreneurship Development Institute has informed that the Engineer–in-Chief (Buildings) Public Works Department has submitted a Revised Administrative proposal for sanction of Rs.5,15,64,315/- (Rupees Five crores fifteen lakhs sixty four thousand three hundred and fifteen only) which was accepted by the 12th Technical Advisory Committee meeting held on 29.05.2013. The additional amount of Rs.27,64,315/- (Rupees Twenty seven lakhs sixty four thousand three hundred and fifteen only) involved is due to Tender excess. Based on this, the Tender Award Committee has accepted the proposal for Rs.5,15,64,315/- (Rupees Five crores fifteen lakhs sixty four thousand three hundred and fifteen only).

- 4. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce has therefore requested the Government to issue necessary orders for according the Revised Administrative Sanction for an amount of Rs.5,15,64,315/- as against the original sanction of Rs 4.88 crores, and sanction a sum of Rs.27,64,315/- as additional fund to complete the Modern Training Complex of Entrepreneurship Development Institute.
- 5. The Government, after careful examination of the proposal of the Principal Secretary / Industries Commissioner and Director of Industries and Commerce accord Revised Administrative Sanction for a sum of Rs.5,15,64,315/- (Rupees Five crore fifteen lakhs sixty four thousand three hundred and fifteen only) and financial sanction for a sum of Rs.27,64,315/- (Rupees Twenty seven lakhs sixty four thousand three hundred and fifteen only) being additional cost for completion of construction work of Modern Training Complex for Entrepreneurship Development Institute.
- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-
 - "2851. 00 Village and Small Industries 102. Small Scale Industries Schemes in the Twelfth Five Year Plan II State Plan ME Grants to Entrepreneurship Development Institute 09. Grants-in-aid 02. Grants for creation of capital Assets" [DPC 2851 00 102 ME 0921]
- 7. Necessary additional funds of Rs.27,64,315/- will be provided in RE/FMA 2014-15. Pending provision of such funds in RE/FMA 2014-15, the Principal Secretary / Industries Commissioner and Director of Industries and Commerce, Chennai 28 is authorized to incur the above expenditure. However, this expenditure will be brought to the notice of the Legislature by specific inclusion in the Supplementary Estimates. He is also directed to issue fund availability certificate to the Engineer in Chief (Buildings) and Chief Engineer (General), Public Works Department for completion of the construction work of Modern Training Complex for Entrepreneurship Development Institute through issue of LOC. The Principal Secretary / Industries Commissioner and Director of Industries and Commerce, Chennai 28 is requested to send necessary draft explanatory note for inclusion of the expenditure in the Supplementary Estimates and to include the above expenditure, while sending the proposal for RE/FMA 2014-2015 to Finance (Industries/BG-II) Department without fail.
- 8. This order issues with the concurrence of Finance department vide its U.O. No.67208 /Ind/2014, Finance (Ind) Department, dated 22.12.2014 and ASL No. 1848 [one thousand eight hundred and forty eight]
