### **ORDER:**

The Government of India in their letter first read above have conveyed the approval for setting up of Common Facility Centre for Printing Cluster, Krishnagiri District, at a total project cost of Rs.1072.52 lakh with the following pattern of funding:

2. As per the guidelines on Micro and Small Enterprises-Cluster Development Programme the cost escalation will be borne by Special Purpose Vehicle / State Government.

3. In the G.O. second read above, the Government have accorded administrative sanction for a sum of Rs.1,00,00,000/- (Rupees One Crore only) being State Government contribution and released a sum of Rs.40,00,000/- (Rupees Forty lakh only) towards cost escalation in setting up of Common Facility Centre for Printing Cluster, Krishnagiri District.

4. In the reference 3<sup>rd</sup> read above, the Government of India, Ministry of Micro, Small and Medium Enterprises have released Rs.200.17 lakh being 2<sup>nd</sup> instalment towards Government of India's grant for setting up of Common Facility Centre for the Printing Cluster, Krishnagiri.

5. In the G.O. 4<sup>th</sup> read above, the Government have sanctioned a sum of Rs.20,00,000/- (Rupees Twenty Lakh only) being 2<sup>nd</sup> instalment towards State Government contribution for setting up of Common Facility Centre in the Printing Cluster, Krishnagiri District.

6. In the reference 6<sup>th</sup> read above, the Government of India, Ministry of Micro, Small and Medium Enterprises have released Rs.198.00 lakh being 3<sup>rd</sup> instalment towards Government of India's grant for setting up of Common Facility Centre for the Printing Cluster, Krishnagiri District.

7. In the reference 7<sup>th</sup> read above, the Government of India, Ministry of Micro, Small and Medium Enterprises have released Rs.96.294 lakh being 4<sup>th</sup> instalment towards Government of India's grant for setting up of Common Facility Centre for the Printing Cluster, Krishnagiri District.

8. In the reference 5<sup>th</sup> read above, the Tamil Nadu Small Industries Development Corporation Limited has requested the Government to release balance grant of Rs.40,00,000/- towards setting up of Common Facility Centre for the Printing Cluster, Krishnagiri under Micro and Small Enterprises - Cluster Development Programme Scheme.

9. The Government after careful consideration of the proposal of the Tamil Nadu Small Industries Development Corporation Limited accord sanction for a sum of Rs.30,00,000/- (Rupees Thirty lakh only) being 3<sup>rd</sup> instalment towards State Government contribution for setting up of Common Facility Centre for Printing Cluster, Krishnagiri District.

10. The amount sanctioned in para 9 above shall be debited to the following head of account:

"2851-00 – Village and Small Industries - 102. Small Scale Industries - Schemes in the Twelfth Five Year Plan – II . State Plan - MG – Provision

of Common facilities for Small Industries Cluster Development Programme  
09. Grants- in-aid- 02. Grants for creation of capital Assets.”

11. Necessary funds of Rs.30,00,000/- will be provided in RE / FMA 2015-16. However, this should be brought to the notice of legislature by specific inclusion in the Supplementary Estimates 2015-16. Pending provision of such funds, the Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the expenditure sanctioned in para 9 above. He is also requested to include the above expenditure while sending proposal for RE /FMA and Supplementary Estimates 2015-2016 to Government in Finance (Ind/BG I) Department without fail.
