ORDER

In the Government Order first read above, orders have been issued that the Central Electrical Testing Laboratory (CETL), Kakkalur would act as the main sampling and inspection agency for the Government Departments / Quasi Government

Departments and Corporations / Boards for their purchase of electrical goods and accessories from Private Industries so as to ensure that the suppliers supply only quality products and that the Central Electrical Testing Laboratory (CETL), Kakkalur acts as a quality consultant for the purchasing Departments. Instructions have also been issued to Heads of Departments to ensure that only the electrical goods and accessories certified by the Central Electrical Testing Laboratory (CETL), Kakkalur are purchased from the suppliers for their Departmental use.

2. In the Government Order second read above, these instructions have been reiterated and all the Heads of Departments / Boards etc., have been requested again to make full use of the Central Electrical Testing Laboratory (CETL), Kakkalur for testing the quality of the electrical goods and appliances etc., purchased for departmental use.

3. In the Government Order third read above, reiterate the instructions stated in the Government Order first and second above once again, the *Heads of Departments / Public Sector Undertakings / Boards / Autonomous Bodies are once again requested to ensure that only the electrical goods and accessories certified by the Central Electrical Testing Laboratory, Kakkalur are purchased from the suppliers for their departmental use. Instructions have also been issued to the Unit / Subordinate Officers who are authorised to make purchases in this regard.*"

4. In the letter fourth read above, the Deputy Director (Electrical & Electronics), Central Electrical Testing Laboratory (CETL), Kakkalur has informed that no samples (with exception of rare cases) pertaining to Government projects / purchases are being received by Central Electrical Testing Laboratory (CETL), Kakkalur. It is observed that the established facilities and expertise available at Central Electrical Testing Laboratory (CETL), Kakkalur is not being made use of in spite of instructions issued by the Government for utilizing the State facilities for testing of electrical products .

5. In the letter fifth read above, the Industries Commissioner and Director of Industries and Commerce has brought to the notice of the Government that the instructions issued in this regard are not strictly adhered to by the Government Departments / Public Sector Undertakings / Boards etc.,

6. The Government reiterate the above instructions once again. The Heads of Departments / Public Sector Undertakings / Boards / Autonomous Bodies are once again requested to ensure that the electrical goods and accessories certified by the Central Electrical Testing Laboratory (CETL), Kakkalur are purchased from the suppliers for their departmental use. Suitable instructions may be issued to Unit / Subordinate Officers who are authorised to make purchases in this regard.


