#### ORDER:

In the G.O. first read above, an Expert Committee has been constituted by the State Government to formulate schemes for revival of MSMEs in Tamil Nadu.

- 2. In the letter second read above, the Tamil Nadu Boilers Association has represented to Government to safeguard the interest of the promoters, workers and employees.
- 3. In the letter third read above, the Industries Commissioner and Director of Industries and Commerce has stated that since the stressed MSMEs in the BHEL cluster of Trichy District form a case study in revival and rehabilitation of MSMEs, it is appropriate to include the same in the Terms of Reference (ToR) of the Expert Committee for revival of MSMEs. In the meantime, during the regular discussion with

the Expert Committee, Industries Commissioner and Director of Industries and Commerce, the Member convener has requested the Committee to pursue the said issue in the Terms of Reference (ToR) Government Order of the Expert Committee in anticipation of Government formal approval. This is in view of the time period of the Committee coming to a close soon.

- 4. Accordingly, the Industries Commissioner and Director of Industries and Commerce, the Member-Convener has arranged a Technical Advisory Team with the following members to support the Committee in this additional Terms of Reference (ToR):-

The Industries Commissioner and Director of Industries and Commerce has also stated that the members were requested to submit their report within 3 weeks period to the committee for revival of MSMEs. The specific term of reference for this Technical Advisory Team shall be "To study the issues of the MSMEs in Trichy District associated with BHEL, Trichy and to suggest a way forward".
- 6. The Industries Commissioner and Director of Industries and Commerce has therefore requested the Government to ratify the action in having constituted the Advisory Team as in para 4 above, to assist the MSME Expert Committee constituted for revival of MSMEs.
- 7. The Government after careful examination of the proposal of Industries Commissioner and Director of Industries and Commerce have decided to accept the above and issue ratification orders for the action of Industries Commissioner and Director of Industries and Commerce in having constituted the Advisory Team as at para 4 above

to assist the MSME Expert Committee constituted for revival of MSMEs, with the Terms of Reference (ToR) "to study the issues of the MSMEs in Trichy District Associated with BHEL, Trichy and to suggest a way forward".
