ORDER:

The Hon'ble Minister (Rural Industries) had made an announcement in the floor of the Assembly during 2020-21 that ISO Quality Certification will be obtained for 15 District Industries Centres in Tamil Nadu at a cost of Rs.26.00 Lakh.

2. In the letter read above, the Industries Commissioner and Director of Industries and Commerce has sent necessary proposal stating that Guidance from Bureau of Indian Standards, Tharamani, Chennai was obtained to get IS/ISO 9001:2015 for 15 District Industries Centres in Tamil Nadu to existing quality Management System Certification License No.Q-ML-6007919 for complying with the norms / procedure the following financial cost involved for 1809001-2015 certification for a District Industries Centres.

The Industries Commissioner and Director of Industries and Commerce has requested the Government to sanction a sum of Rs.4,01,200/- for obtaining ISO 9001-2015 certification for 15 District Industries Centres Dindigul, Erode, Kanniyakumari, Salem, Thanjavur, Thoothukudi, Tirunelveli, Tiruppur, Trichy, Vellore, Karur, Dharmapuri, Krishnagiri, Namakkal and Virudunagar in Tamil Nadu.

4. The Government after careful consideration of the proposal of Industries Commissioner and Director of Industries and Commerce sanction a sum of Rs.4,01,200/- (Rupees Four lakh one thousand and two hundred only) to obtain the ISO 9001/2015 certificate for 15 District Industries Centres as stated at para 3 above.

5. The amount sanctioned in para 4 above shall be debited to the following Head of Account:-

"2852 Industries – 80 General - 001 Direction and Administration; – State Expenditure - JE Revamping of District Industries Centres - Including Head quarters – 333 Payments for Professional and Special Services - 09 - Other Payments".

6. Necessary, additional funds of Rs.4,01,200/- will be provided in RE/FMA 2020-21. Pending provision of such funds, the Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in para 4 above. The Industries Commissioner and Director of Industries and Commerce is also directed to include this item of expenditure while sending the budget proposal for RE/FMA 2020-2021 to Government in Finance (Industries) Department at the appropriate time without fail.


