ORDER:

In the Government letter first read above, this Government forwarded the revised proposal for setting up Common Facility Centre for Rice Mill Cluster, Alangulam, Tirunelveli District under Micro and Small Enterprises–Cluster Development Programme.

2. The Government of India in their letter second read above have conveyed the approval for setting up of Common Facility Centre for Rice Mill Cluster, Alangulam, Tirunelveli District at a total project cost of Rs.787.00 lakhs with the following pattern of funding:

3. According to Para 9(g) of guidelines for Micro and Small Enterprises–Cluster Development Programme, contribution by Special Purpose Vehicle / State Government or the beneficiaries should be made upfront. The Government of India will release the fund only after release of fund from the State Government.

4. The General Manager, Tamil Nadu Small Industries Development Corporation Limited has therefore requested the Government to sanction of Rs.55.23 lakhs out of its committed contribution as first instalment to the Rice Mill Cluster, Alangulam, Tirunelveli District.

5. The Government after careful examination of the proposal of Chairman and Managing Director, Tamil Nadu Small Industries Development Corporation Limited and accord sanction for a sum of Rs.55,23,000/- (Rupees Fifty Five Lakhs and twenty three thousand only) being 70% of the State Government's contribution of Rs. 78,91,000/- as first instalment for setting up of Common Facility Centre for Rice Mill Cluster at Alangulam in Tirunelveli District under Cluster Development Programme in Micro and Small Enterprises.

6. The amount sanctioned in Para 5 above shall be debited to the following head of account:

“2851-00 – Village and Small Industries - 102. Small Scale Industries - Schemes in the Twelfth Five Year Plan – II . State Plan - MG – Provision of Common facilities for Small Industries Cluster Development Programme 09. Grants- in-aid- 02. Grants for creation of Capital Assets.

7. This expenditure shall be constituted as ‘New Instrument of Service’ and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will initially be met by sanction of advance from Contingency Fund, regarding which, orders will be issued by Government in Finance (BG.I) Department. The Industries Commissioner and Director of Industries and Commerce is requested to apply in the prescribed format along with a copy of this order to Finance (BG.I) Department for sanction of advance from the Contingency Fund. He is also directed to send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2013-14.

8. This order issues with the concurrence of Finance Department vide its U.O. No. 363/Ind/2014 dated 13.1.2014 and ASL No.2623 [Two thousand six hundred and twenty three]
