ORDER:

The Director, Entrepreneurship Development Institute has sent the proposal indicating two main programmes as follows:

i. Skill – cum – Entrepreneurship Development Programmes:

In the past, Entrepreneurship Development Institute has been implementing various types of programmes including Entrepreneurship Development Programmes (EDPs), Entrepreneurship and Skill Development Programmes (ESDPs), Technology Entrepreneurship Development Programmes (TEDPs), Women Entrepreneurship Development Programmes (WEDPs) and Women Entrepreneurship and Skill Development Programmes (WESDPs)

It has been proposed to have one standard Entrepreneurship and Skill Development Scheme, which can be used for different types of target groups and skill requirements.

2. The objective of the Entrepreneurship and Skill Development Programmes is to provide training, technical skills, skill upgradation and entrepreneurship skills so as to equip the trainees start ventures in specific areas. Entrepreneurship and Skill Development Programmes could cover a variety of technical skills including engineering related skills.

The eligibility will be Minimum 12th pass / Degree / Diploma Holders / ITI / VTP will be given preference. Duration is 150 hours (25 days). Age group will be from 18 – 35 years (relaxable upto 5 years in deserving cases).

ii. Entrepreneurship Awareness Programmes:

The Programme is designed to create awareness and interest among college students on entrepreneurship opportunities and to guide prospective entrepreneurs through the process of establishing start-ups.

The Entrepreneurship Awareness Programme will be conducted in 100 colleges in association with reputed institutions in three phases as detailed below:

Phase I & II

- One day Awareness Programme shall be conducted for students in the 100 colleges. 20 students from each college shall be selected based on bilingual test / questionnaire.
- 30 Hrs (5 days) entrepreneurship training programme shall be conducted for 2000 (20 X 100) students, including field visit and exposure to real world entrepreneurial situations.
- Two students with the best project / ideas shall be selected per colleges (Total = 200 students)

Phase III

- Advanced orientation programme shall be selected for the selected 200 students at Chennai including visit to incubation centres, industrial parks and other facilities.

3. The Director, Entrepreneurship Development Institute has requested the Government to consider the above proposal and sanction the grant of Rs.1,90,01,600/- so as to enable them to commence and implement the proposed programmes for the year 2015-16.

4. The Government after careful examination of the proposal of the Director, Entrepreneurship Development Institute accord sanction for a sum of Rs.1,90,01,600/- (Rupees One crore ninety lakh one thousand and six hundred only) as grant towards commencement and implementation of the above programmes for the year 2015-16.

5. The amount sanctioned in Para 4 above shall be debited to the following head of account:

“2851-00-Village and Small Industries - 102 Small Scale Industries – Schemes in the Twelfth Five Year Plan – II State Plan - ME Grants to Entrepreneurship Development Institute – 09 Grants in Aid – 03 Grants for Specific Schemes”.

6. The expenditure sanctioned in para 4 above shall constitute an item of New Instrument of Service and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2015-16. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Industries Commissioner and Director of Industries and Commerce is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.1) Department. The Industries Commissioner and Director of Industries and Commerce shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2015-16 to Finance (Ind) Department without fail.

7. The Industries Commissioner and Director of Industries and Commerce is authorized to draw and disburse the amount sanctioned in para 4 above to the Entrepreneurship Development Institute. The Director, Entrepreneurship Development Institute is requested to send the Utilization Certificate in this regard to the Government.
