

I am directed to state that, in the letter cited, the Secretary, Tamil Nadu Information Commission has informed that the Public Information Officer, Office of the Joint Commissioner (CT), Enforcement-I, Greams Road, Chennai – 600 006 has filed Writ Petition.No.5992 of 2017 in the High Court of Madras challenging the orders of the Tamil Nadu Information Commission, dated 22.09.2015 in SA.No.12009/F/2015 (Case No.2783/Enquiry/F/2013) (14249/2014). In the Commission's order, the Public Information Officer was ordered to pay a penalty of Rs.25,000/-, vide section 20(1) of the Right to Information Act, 2005 besides it was also recommended to initiate disciplinary proceedings by the appropriate authority against the Public Information Officer as per section 20(2) of the Right to Information Act, 2005. While the aggrieved person has a right to move the Court, it is seen that in this case, the Special Government Pleader (Taxes) is shown as the counsel for the Writ Petitioner. In effect, Government machinery has been used to thwart an order of the Commission.

The Commission feels that it is not fair or correct for a Government counsel to be a party to challenge the orders of the Tamil Nadu Information Commission on behalf of a person penalized by the Tamil Nadu Information Commission. Hence, the Tamil Nadu Information Commission has requested to issue suitable instructions to all concerned.

2. The Government have carefully examined the request of the Secretary, Tamil Nadu Information Commission and direct that in all the cases where the Public Information Officer has been penalized under section 20 of the Right to Information Act by the Tamil Nadu Information Commission, the Public Information Officer shall not engage the Government Counsel to defend the case against the orders of the State Information Commission.
