Sub: Public Services – Wearing of Photo Identity Cards compulsorily by all Government Servants – Instructions – reiterated – Regarding.

The Government have issued Orders / Instructions in the reference first to fifth cited from time to time to all Head of the Departments so as to emphasize that all the Government Servants shall wear photo identity card compulsorily during office hours without fail.

- 2. Further, the Hon'ble High Court of Madras in its judgment dated 16.07.2018 in W.P.No.15640/2018, among others has directed to ensure that rule regarding wearing of identity cards is strictly enforced and action should be taken against those flouting the Rules. Based on the above orders, in the reference seventh cited the orders/instructions regarding wearing of photo identity card by the Government Servants were reiterated. In spite of that complaints are received in the Government that most of the Government Servants are not wearing their Photo Identity cards while on duty.
- 3. Hence, all Head of the Departments / District Collectors are requested to give suitable instructions to the subordinate offices under their control to instruct the employees to wear photo identity cards without fail as per the norms and instructions specified in the Government Orders/Instructions issued in the references cited. Non-wearing of photo Identity cards may be viewed seriously, and disciplinary action may be initiated against the erring individuals.
