### ORDER:

The State of Kerala has witnessed a heavy rainfall during the month of August 2018, which caused and devastation to the infrastructure in several Districts of the State, besides loss of many lives. The Government of India has declared the devastating floods in the State of Kerala as a "Calamity of severe nature". There is an urgent need for joining hands in the rebuilding efforts.

- 2. Some of the service associations of Tamil Nadu Government Employees and Teachers have expressed their willingness to contribute One day's salary of their members towards the relief and rehabilitation measures in the State of Kerala.
- 3. The Government have decided to accept the requests of the service associations of Government Employees and Teachers, and direct that the voluntary contributions of One day's salary shall be deducted from the salary bill of the Government Employees and Teachers for the month of August or September, 2018 towards the relief and rehabilitation measures in the State of Kerala.
- 4. Accordingly, any employee willing to voluntarily contribute One day's salary to the relief and rehabilitation measures taken up in the State of Kerala, shall give his/her willingness in writing to the concerned Drawing and Disbursing Officers. The Drawing and Disbursing Officers shall make use of the provisions in the Web Payroll application for the calculation of One day's salary in the month of August or September, 2018 pay bill as the case may be. The amount shall be deducted on the basis of the gross amount of salary for the month of August or September, 2018 and the same shall be credited directly to the Chief Minister's Distress Relief Fund Savings Bank account maintained at State Bank of India, City Branch, Thiruvananthapuram (SB A/c No. 67319948232, IFSC Code: SBIN0070028, Swift Code: SBININBBT08, PAN: AAAGD0584M) on the due date of disbursement of salary.

- 5. In respect of self drawing officers, the same procedures outlined above shall be followed.
- These shall apply mutatis mutandis to the employees of Local Bodies, Universities, Boards and Corporations, Aided Educational Institutions and other institutions receiving grants from the Government and also to the employees drawing Consolidated Pay.
- 7. The Drawing and Disbursing Officers shall inform the Heads of Department concerned regarding the details on the ECS mode of deduction from the monthly pay bill and the total amount credited to the CMDRF account of the State of Kerala, along with the list of employees by whom the contributions were made. The Heads of Department in turn shall send the consolidated details to the Government in Personnel and Administrative Reforms department and the Commissionerate of Treasuries and Accounts, Chennai.
- 8. The Principal Secretary / Commissioner of Treasuries and Accounts, Chennai is requested to intimate the Government about the exact amount transacted towards contribution of One day's salary of the employees to the CMDRF account of the State of Kerala for its relief and rehabilitation measures.
- 9. The Drawing and Disbursing Officers shall ensure that the contributions are made purely voluntarily and the above procedures have been evolved in order to facilitate the requests made by the service associations of Government Employees and Teachers for contribution to the relief and rehabilitation measures in the State of Kerala.
- 10. This order issues with the concurrence of the Finance Department vide its U.O. No.3275/ACS(FAC)/P/2018, Dated 24.8. 2018.
