ORDER:

In the Government Order first read above, orders were issued prescribing the educational qualification of 'A Bachelor's Degree viz., B.Com, B.A(Economics) and B.Sc (Statistics)' for appointment to the post of Section Officer / Under Secretary to Government in Finance Department by recruitment by transfer / promotion from the category of Assistant Section Officer / Section Officer.

- 2. In the Government Order second read above, orders have been issued superseding the orders issued in the reference first read above, prescribing the qualification of 'A Bachelor's Degree / Master's Degree in Commerce or Economics or Statistics' for appointment to the post of Section Officer / Under Secretary to Government in Finance Department by recruitment by transfer / promotion from the category of Assistant Section Officer / Section Officer.
- The following Notification will be published in the <u>Tamil Nadu</u> <u>Government Gazette</u>:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Service (Section 16 in Volume II of the Tamil Nadu Services Manual, 1969)

2. The amendments hereby made shall be deemed to have come into force on the **21**st May **2014**.

AMENDMENTS.

In the said Special Rules, in Class-XII, in the Annexure referred to in rule 3:-

- (1) for the entries in column (3), against the entry "Under Secretary in Finance Department" in column (1) and the entry "Promotion from among the holders of the post of Section Officer in the Finance Department in Category 3" in column (2) thereof, the following entries shall be substituted, namely:-
 - "(i) Must hold a Bachelor's degree or Master's degree in Commerce or Economics or Statistics of any University recognised by the University Grants Commission:

Provided that nothing contained in this clause shall adversely affect the persons in service in Finance Department including Planning, Development and Special Initiatives Department, holding any degree recognised by the University Grants Commission as on the 21st May 2014;

- (ii) Must have worked as Section Officer in the sections dealing with matters relating to Budget for a period of not less than one Budget session; and
- (iii) Must have undergone District Training for a period of six months."
- (2) for the entry in column (3), against the entry "Section Officer in the Finance Department" in column (1) and the entry "Recruitment by transfer from among the holders of the post of Assistant (now Assistant Section Officer with effect from the 30th November 1984) in the Finance Department in the Tamil Nadu Secretariat Service" in column (2) thereof, the following entries shall be substituted, namely:-

"(i) Must hold a Bachelor's degree or Master's degree in Commerce or Economics or Statistics of any University recognised by the University Grants Commission:

Provided that nothing contained in this clause shall adversely affect the persons in service in Finance Department including Planning, Development and Special Initiatives Department, holding any degree recognised by the University Grants Commission as on the 21st May 2014;

(ii) Must have worked as Assistant (now Assistant Section Officer with effect from the 30th November 1984) in the sections dealing with matters relating to Budget for a period of not less than one Budget session."
