NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules.

2. The amendments hereby made shall be deemed to have come into force on the 16th May 2011.

AMENDMENTS.

In the said Fundamental Rules, in rule 101, under the heading, "Instructions under Rule 101(a) - Maternity Leave", -

(1) in Instruction 1, for the expression "90 days" wherever it occurs, the expression "180 days" shall be substituted.

(2) in Explanation 2 under Instruction 1, for the expression "90 days", the expression "180 days" shall be substituted.
