ORDER:

In the Government Order first read above, the Government have constituted the Tamil Nadu State Information Commission under sub-section (1) of Section 15 of the Right to Information Act, 2005. In the Government order 5th read above orders have been issued that Thiru K. Ramanujam, I.P.S., (Rtd) ceases to hold the post of the State Chief Information Commissioner after attaining the age of 65 years as on 22.11.2017 as provided in sub-section (1) of Section 16 of the Right to Information Act, 2005. In the Government order 2nd, 3rd and 4th read above orders have been issued that Tvl. / Tmt. S.F. Akbar, Christopher Nelson, I.P.S., (Rtd.), P. Tamilselvan and B. Neelambigai cease to hold the post of the State Information Commissioners.

2. The Governor of Tamil Nadu has decided to appoint Dr. M. Sheela Priya, I.A.S., (Retd) as State Chief Information Commissioner. The Governor has also decided to appoint Tvl. S. Selvaraj, S.T. Tamilkumar, R. Pratapkumar and S. Muthuraj as State Information Commissioners in the Tamil Nadu Information Commission.

3. The following Notification shall be published in the Tamil Nadu Government Gazette Extraordinary, dated 30th November 2017.

NOTIFICATION

In exercise of the powers conferred by sub-section (3) of Section 15 of the Right to Information Act, 2005 (Central Act 22 of 2005), the Governor of Tamil Nadu hereby appoints Dr. M. Sheela Priya, I.A.S., (Retd) as State Chief Information Commissioner and Tvl. S. Selvaraj, S.T. Tamilkumar, R. Pratapkumar and S. Muthuraj, as State Information Commissioners in the Tamil Nadu Information Commission.

4. The above State Chief Information Commissioner and State Information Commissioners shall hold office for a term of five years from the date on which they enter upon their office or the date on which they attain the age of sixty-five years, whichever is earlier.
