ORDER:

In the Government Order first read above and subsequent instructions there under, among others, consolidated orders have been issued forming Review Committees to review cases of Government servants (Group A, B, C & D) with i) lack of integrity, ii) habitual bribe takers, iii) physically / mentally not in good condition, iv) repeated complaints of corruption and v) not able to perform efficiently for the next 3 / 5 years, under rule 56 (2) of Tamil Nadu Fundamental Rules for compulsory retirement.

2. In his letter sixth read above, the Deputy Secretary to Governor, Governor's Secretariat, has requested to form two Committees to review Government Servants in Governor's Secretariat under FR 56 (2), one with the Additional Chief Secretary to Hon'ble Governor as Chairman and the Deputy Secretary to Governor (Universities) and Deputy Secretary to Governor (Comptroller) as its Members to review Group A & B officers; and the second with

Deputy Secretary to Governor (Universities) as Chairman and Deputy Secretary to Governor (Comptroller) & Under Secretary to Governor (Tours) as its Members to review Group C & D.

3. The Government have examined the above proposal of the Governor's Secretariat and constitute the following two Committees to review Government servants in the Raj Bhavan for compulsory retirement under FR 56 (2) in supersession of earlier orders constituting the Review Committee under FR 56 (2) in respect of Raj Bhavan subject to the guidelines and instructions issued in the Government orders first and fifth read above:-

(i) Committee to review Group A & B officers of Raj Bhavan under FR 56(2).

- Chairman: Additional Chief Secretary / Principal Secretary / Secretary to Hon'ble Governor.
- Member: Principal Secretary / Secretary to Government, Public department, Secretariat (or) an officer nominated by him.
- Member: Deputy Secretary to Governor & Comptroller.

(ii) Committee to review Group – C & D staff of Raj Bhavan under FR 56(2).

- Chairman: Deputy Secretary to Governor (Universities)
- Member: Deputy Secretary to Governor & Comptroller
- Member: Under Secretary to Governor (Tours)
