**NOTIFICATION.**

The Governor of Tamil Nadu hereby makes the following amendment to the Fundamental Rules and the Instructions thereunder.

2. The amendment hereby made shall be deemed to have come into force on the date of issue of order.

**AMENDMENT.**

In the said Fundamental Rules, in rule 106, under the heading, "Instructions under Rule 106" in Instruction 15, the following proviso shall be added, namely:-

"Provided that on implementation of the Integrated Financial and Human Resources Management System, the condition that the Government servant

should apply for the credit of unavailed joining time within six months from the date of his transfer need not be insisted by the authorities concerned".
