Fees – Revision of rates of examination fees for the various competitive examinations conducted by the Tamil Nadu Public Service Commission and to extend the concession of three free chances to all Backward Classes, Backward Classes (Muslims) and Most Backward Classes candidates, irrespective of educational qualification – Orders– Issued.

### **ORDER:**

As specified in Article 320 of the Constitution of India, one of the major functions of the Tamil Nadu Public Service Commission is to conduct examinations for selection of candidates under direct recruitment to the State, Subordinate and Ministerial Services etc.

2) As per section 8 of the Tamil Nadu Government Servants (Condition of Service) Act, 2016, every candidate for appointment to any service, who, in response to a notification issued by the Commission, makes an application, shall remit the fee that may be prescribed by the Government, from time to time. Accordingly, the fee structure payable by the candidates applying / appearing for the various competitive examinations conducted by the Tamil Nadu Public Service Commission was lastly fixed in the G.O. first read above. Moreover, a new system of online registration of candidates appearing for competitive examinations was introduced by the Tamil Nadu Public Service Commission during the year 2012 on payment of Rs.30/-. This online registration is valid for a period of 5 years from the date of registration.

3) The Secretary, Tamil Nadu Public Service Commission, in his letters 2<sup>nd</sup> & 3<sup>rd</sup> read above, has requested to enhance the fee structure payable by the candidates applying / appearing for the various competitive examinations conducted by the Tamil Nadu Public Service Commission and to extend the concession of three free chances of exempting from the payment of examination fee to all Backward Classes, Backward Classes (Muslims) and Most Backward Classes candidates, irrespective of their educational qualification.

4) The Government, after detailed examination, accept the proposal of the Secretary, Tamil Nadu Public Service Commission and accordingly revise the rates of examination fee for applying / appearing various competitive examinations conducted by the Tamil Nadu Public Service Commission as detailed below :-

5) The above revision of examination fee will take effect from the 1<sup>st</sup> March, 2017. The Secretary, Tamil Nadu Public Service Commission is therefore requested to adopt the new fee structure in the notifications to be issued with effect from 1<sup>st</sup> March, 2017.
