From the Principal Secretary/Commissioner of Treasuries and Accounts, Chennai-35. Letter No.048220/IFMS/2016-2, dated 20.12.2018.

ORDER:

The Principal Secretary/Commissioner of Treasuries and Accounts in his letter read above has stated that under IFHRMS, the system contemplates end to end solution for all financial activities, various rules, procedure for drawing payments from Treasuries and they are all made as inbuilt in the system. The objective of this Project is to remove various systemic deficiencies in the manual legacy system of operation and optimizing efficiency through comprehensive business process re-engineering.

- 2. In view of the implementation of IFHRMS, Human Resource Management is linked with pay roll and unless the e-Service Register is opened to the newly recruited employee, his pay and allowances cannot be auto generated in the pay roll. He has, therefore, suggested that the Heads of the Departments may be ordered to open the e-Service Register to newly appointed Government Servants immediately on their joining atleast within first month of joining so as to enable the Drawing and Disbursing Officers to claim their pay and allowances in time and to avoid complaints from the newly joined employees.
- 3. The Principal Secretary/ Commissioner of Treasuries and Accounts has therefore requested that the Government may issue suitable orders to incorporate the following provision under Fundamental Rules 10 to open e-Service Register to newly recruited Government Servants immediately on their joining or at least within First month of their joining to enable the Drawing and Disbursing Officers to claim the pay and allowances of newly recruited Government servant without delay, after complying with the due procedure for certificate verification (educational/ technical qualification etc.,)

- 4. The Government have examined the above proposal and decided to accept it. Accordingly, the Government directed that all the Secretaries to Government / Heads of the Departments/ Heads of Offices shall make necessary arrangements to open e-Service Register to newly appointed Government servants immediately on their joining or before the date of presentation of Salary Bill to enable the Drawing and Disbursing Officers to claim the pay and allowances of newly recruited Government servants under IFHRMS. The procedure for certificate verification (educational/ technical qualification etc.,) shall be done in parallel."
 - 5. Necessary amendments to fundamental Rules will be issued separately.
