NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules and the Instructions thereunder.

2. The amendment hereby made shall be deemed to have come into force on the 10th day of March 2020.

AMENDMENTS.

In the said Fundamental Rules,-

- (1) in rule 22, under the heading "RULINGS", ruling (30) shall be omitted;
- (2) in rule 22-B, under the heading "RULINGS", in ruling (2) (iii), after the expression "advance increments", the expression "prior to 10.03.2020" shall be inserted;

- (3) in rule 27, under the heading "RULINGS", rulings (10), (11) and (16) shall be omitted;
- (4) in rule 31-A, under the heading "RULINGS", rulings (3) and (4) shall be omitted.
