## ORDER:

In the Government Order first read above, orders were issued to set up an institute of Management by the name 'Madras Institute of Management' at Chennai. Subsequently, in the Government Order second read above, the name was changed as "Anna Institute of Management". Further, in the Government Order third read above, the name was changed as "Anna Institute of Management Society" and it has been registered under the Tamil Nadu Societies Registration Act, 1975 (Tamil Nadu Act, 27 of 1975).

- 2. In the Government Order fourth read above, the institute was upgraded as "Administrative Training Institute" of the State and the nomenclature of the Director was changed as Director, Anna Institute of Management and Director General of Training (Ex-officio).
- 3. The Director, Anna Institute of Management and Director General of Training in his letter fifth read above has stated that Anna Institute of Management is offering training to various Department Government officials of State and Central,

Public Sector Undertakings in the area of General Administration, Information Technology, Behavioral Science, Quality Management, Project Management, Personality Development, etc., He has also stated that as Anna Institute of Management is the apex State Training Institute for imparting various training programmes to all Department Government Officials, the institution concentrates and performs the activities relating to "Training" and not on "Management". He has requested the Government to change the nomenclature of "Anna Institute of Management" either as "Anna Administrative Training Institute" or "Anna Administrative Staff College".

4. The Government have examined the proposal of the Director, Anna Institute of Management and Director General of Training. After detailed examination, the Government have decided to change the nomenclature of Anna Institute of Management as "Anna Administrative Staff College" and issue orders accordingly.
