ORDER:

The Secretary, Tamil Nadu Information Commission in the letter read above has requested the Government to accord administrative sanction for a sum of Rs.8,90,663/-(Rupees eight lakhs ninety thousand six hundred and sixty three only) for fixing dedicated lease line of 8 mbps connectivity to the Tamil Nadu Information Commission based on the announcement made by the Hon'ble Minister for Municipal Administration, Rural Development, Law, Courts and Prisons in the Floor of Assembly during the Budget session on 23.09.2015 in Demand No.35 of 2015-2016. The Secretary, Tamil Nadu Information Commission has furnished necessary quotation from BSNL.

2. The Government after careful examination, accept the proposal of the Tamil Nadu Information Commission and accordingly sanction a sum of Rs.8,90,663/-(Rupees eight lakhs ninety thousand six hundred and sixty three only) for fixing dedicated lease line of 8 mbps connectivity as specified in para-1 above to the Tamil Nadu Information Commission.
