2. As per sub-section (2) of section 16 of the Right to Information Act, 2005 (Central Act 22 of 2005) the term of the State Information Commissioner is as follows:-

“Every State Information Commissioner shall hold office for a term of five years from the date on which he enters upon his office or till he attains the age of sixty-five years, whichever is earlier, and shall not be eligible for reappointment as such State Information Commissioner.”

Thiru S.F. Akbar, State Information Commissioner, attains the age of sixty five years on 04.11.2015 A.N.

3. The following Notification shall be published in the Tamil Nadu Government Gazette Extraordinary, dated 4th November, 2015.


