#### ORDER:

As per the orders issued in the Government Order second read above Thiru R. Dakshinamurthy, entered upon office as State Information Commissioner, Tamil Nadu Information Commission on 09.08.2015 F.N.

2. The term of office of State Information Commissioner as per sub-section (2) of section 16 of the Right to Information Act, 2005 (Central Act 22 of 2005) as it stood prior to the coming into force of the Right to Information (Amendment) Act, 2019 and the rules made thereunder, which is applicable to Thiru R. Dakshinamurthy who was appointed prior to the Amendment reads as follows: -

"Every State Information Commissioner shall hold office for a term of five years from the date on which he enters upon his office or till he attains the age of sixty five years, whichever is earlier, and shall not be eligible for reappointment as such State Information Commissioner."

- Thiru R. Dakshinamurthy, State Information Commissioner, attains the age of sixty five years on 19.05.2020 A.N.

On attaining the age of sixty-five years, Thiru R. Dakshinamurthy, State Information Commissioner, Tamil Nadu Information Commission shall cease to hold office on the afternoon of 19.05.2020 as provided in sub-section (2) of section 16 of the Right to Information Act, 2005 (Central Act 22 of 2005).
