ORDER:

In the Government Order first read above, among others, the minimum and maximum age limits for recruitment to the posts included in the Group – I Services conducted by the Tamil Nadu Public Service Commission were prescribed as follows:-

Minimum age limit:-

21 years for all categories.

Maximum age limit:-

- (i) 35 years for candidates belonging to Scheduled Castes / Scheduled Tribes, Most Backward Classes / Denotified Communities and Backward Classes; and
 - (ii) 30 years for others.

2. The Tamil Nadu Public Service Commission conducts the examinations for the following posts under Group-I, I-A and I-B Services:-

3. Considering the repeated requests of the aspirants to Group-I examination, the Hon'ble Chief Minister, under rule 110 of the Tamil Nadu Legislative Assembly Rules, on 01.06.2018, made the following announcement on the Floor of the Tamil Nadu Legislative Assembly:-

அதன் அடிப்படையில், மத்திய அரசுப் பணியாளர் தேர்வாணைய தேர்வுகளுக்கு உள்ள வயது உச்சவரம்பினைப் போல, தமிழ்நாடு அரசுப் பணியாளர் தேர்வாணையத்தால் நடத்தப்படும் குரூப்-1, 1- A, 1-B பணியிடங்களுக்கு தற்போதுள்ள SC / ST / MBC / BC & DNC பிரிவினர்களுக்கான வயது உச்சவரம்பு 35-லிருந்து 37 ஆகவும், இதர பிரிவினருக்கு தற்போதுள்ள வயது உச்சவரம்பு 30-லிருந்து 32 ஆகவும் உயர்த்தப்படுகிறது".

4. Accordingly, the Government hereby issue orders to enhance the maximum age limit for candidates appearing for the competitive examinations for the Group-I, I-A and I-B Services conducted by the Tamil Nadu Public Service Commission, as indicated below, based on age limits prescribed for the Civil Services Examination conducted by the Union Public Service Commission:-

Category	Minimum age limit	Maximum age limit	
Scheduled Castes, Scheduled Tribes, Most Backward Classes, Denotified Communities and Backward Classes	21 years	37 years	
Others	21 years	32 years	

Necessary amendments to the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 [Tamil Nadu Act 14 of 2016] will be made separately.
