### ORDER:

Based on the importance of Sustainable Development Goals, in the Government Order second read above, the Government have ordered for formation of Sustainable Development Goals Units in the Departments at Secretariat / Head of Department / Division / District and Sub-District Levels by designating the appropriate officials responsible for monitoring and coordination of the programmes identified as critical to achieving the Sustainable Development Goals, that would assist the Department and strengthen it in the work of the Department in relation to Sustainable Development Goals.
